THE MORTGAGOR-FURTIUR COVENANTS that:

- 1. Mortgagor is the owner of said premises in fee simple or such other estate as is stated herein.
- 2. Mortgagor will pay the indebtedness as provided in said note and this mortgage. Privilege is reserved to prepay at any time, without premium or fee, the entire indebtedness or any part thereof not less than the amount of one installment, or one hundred dollars (\$100.00), whichever is less. Processing Charge: Upon application for approval to allow assumption of this loan, a processing fee may be charged by the toan holder or its authorized agent for determining the creditworthiness of the assumer and subsequently revising the tradec's ownership records when any approved transfer is completed. The amount of this charge shall not exceed the maximum established by the Veteran's Administration for a loan to which section 1814 of chapter 37, title 38, United States Code applies.
