Mortgage is hereby declared fully paid, satisfied and released.

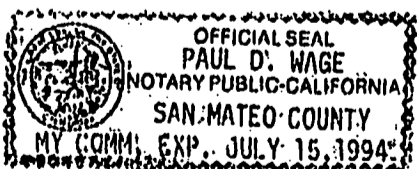
