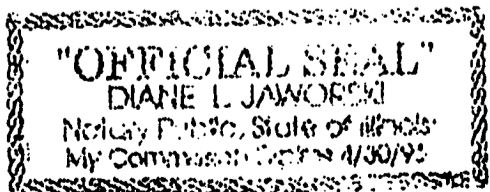

The West 150 feet, by parallel lines, of that part of the Northeast quarter (NE 1/4) of the Northeast quarter (NE 1/4) of Section 18, Township 35 North, Range 9 West of the Second P.M., Lake County, Indiana; described as follows: Beginning at a point in the South line of the said Northeast quarter (NE 1/4) of the Northeast quarter (NE 1/4), 420 feet West of the Southeast corner of said Northeast quarter (NE 1/4) of the Northeast quarter (NE 1/4); thence North along a line 420 feet West of and parallel to the East line of said Northeast quarter (NE 1/4) to a point in the Southerly line of the public highway known as the Lincoln Highway; thence Westerly along said Southerly line of the Lincoln Highway, a distance of 450.90 feet to a point; thence South along a straight line to a point in said South line of the Northeast quarter (NE 1/4) of the Northeast quarter (NE 1/4) said point being 868.90 feet West of the Southeast corner of the Northeast quarter (NE 1/4) of the Northeast quarter (NE 1/4); thence East along said South line of the Northeast quarter (NE 1/4) of the Northeast quarter (NE 1/4) a distance of 448.90 feet to the point of beginning.
