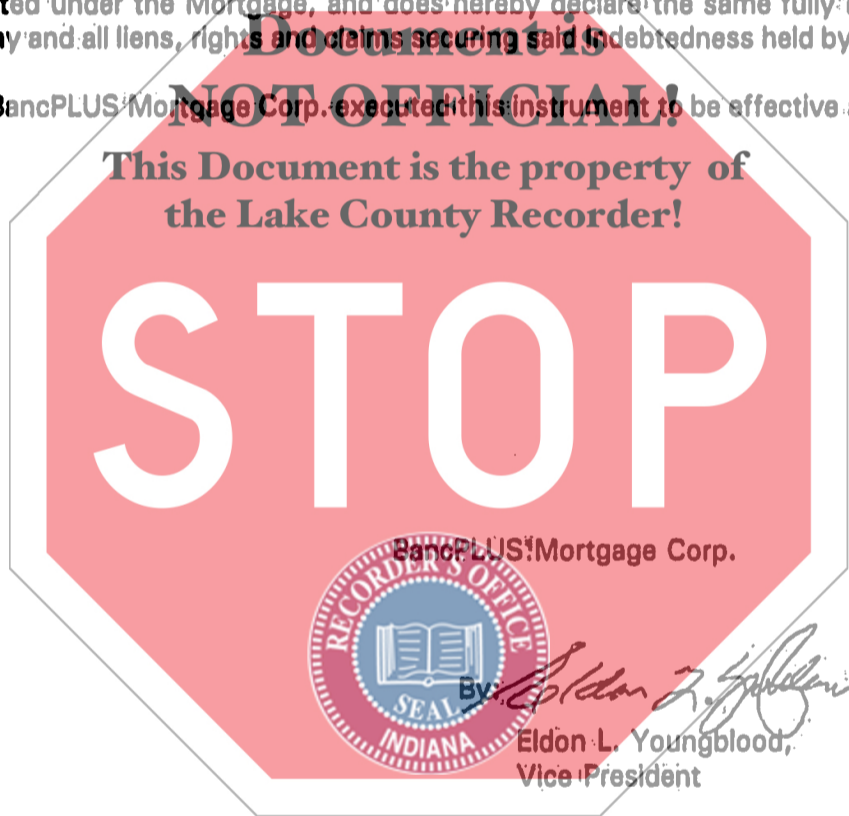
Satisfaction of Mortgage

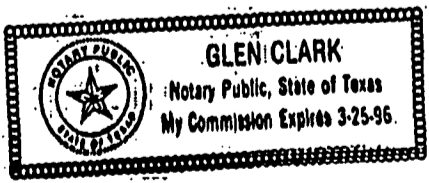
