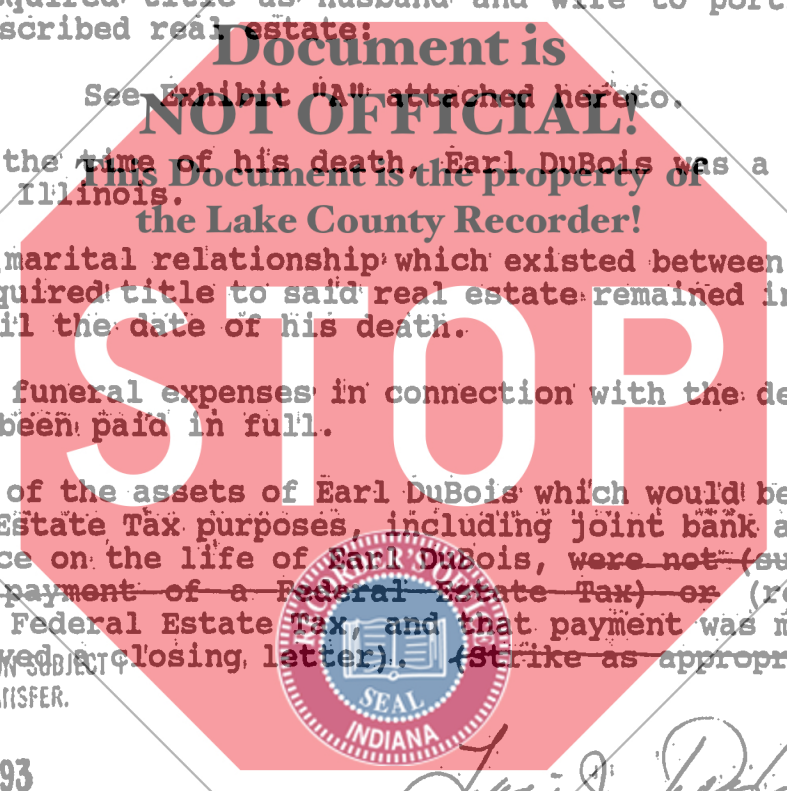
3. At the time of his death, Earl DuBois was a resident of Cook County, Illinois.

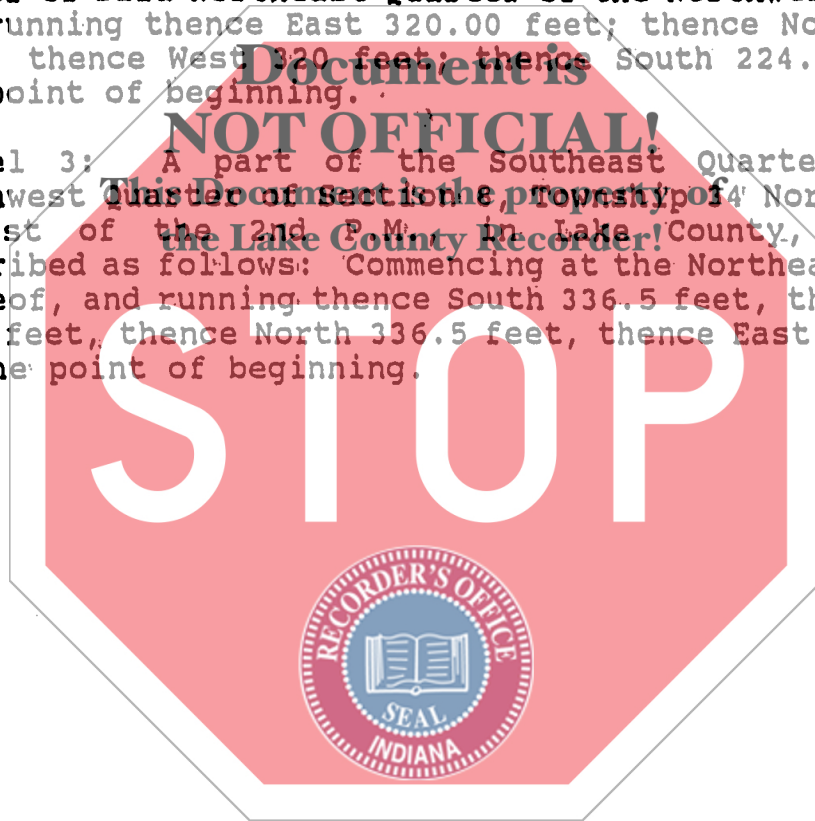
