**DISCLAIMER OF PROPERTY INTEREST**

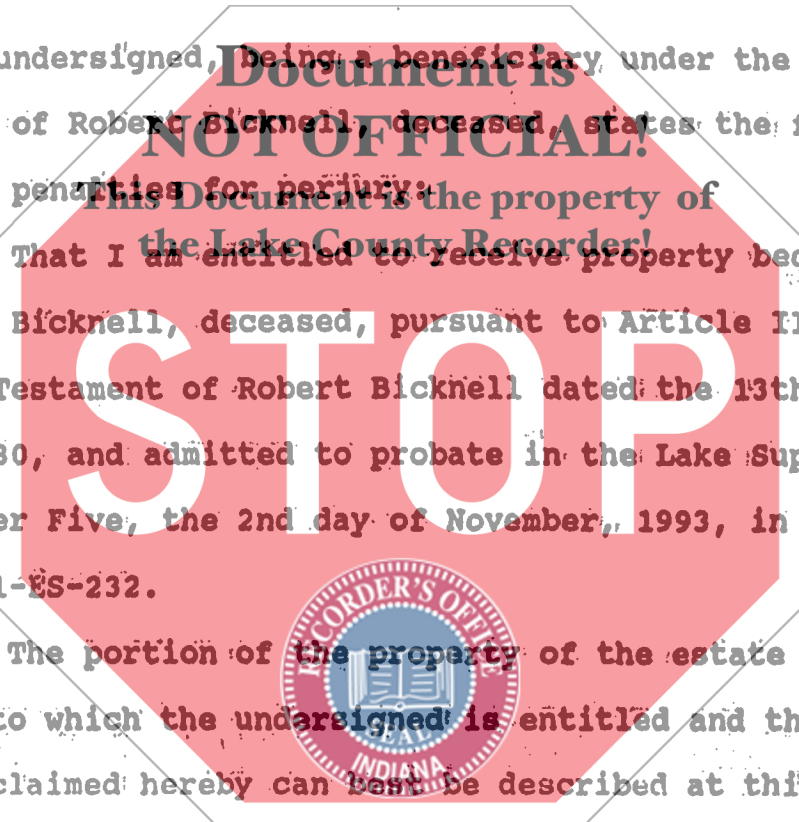
The undersigned, being a beneficiary under the Last Will and Testament of Robert Bicknell, deceased, states the following under the penalties for perjury:
