

4. On August 6, 1993, the Court found the Petitioner, Richard A. Mayo, in contempt of court for failing to comply with court orders. At that time, the Court sentenced the Defendant, Richard A. Mayo, to ninety (90) days in the Lake County Jail, but withheld the execution of said sentence until September 7, 1993, at which time the Petitioner, Richard A. Mayo, was ordered to reappear in court at 9:00 a.m.

5. The Respondent, Richard A. Mayo, failed to appear in court on September 7, 1993, at 9:00 a.m.

6. The Court further ordered the Petitioner, Richard A. Mayo, to have himself evaluated for possible chemical dependence, and, if required, to attend a rehabilitation program.

7. The Petitioner, Richard A. Mayo, has failed to comply with this order of court.

8. Petitioner, Richard A. Mayo, was further ordered to produce in court on September 7, 1993, all evidence of his attempts to obtain employment, including all job applications and statements of any income earned in 1993. The Petitioner, Richard A. Mayo, has failed to comply with this order of court.

9. The Petitioner, Richard A. Mayo, was further ordered to make serious attempts at obtaining employment; to begin making child support payments, including payments on arrearages, and to reimburse the Respondent, Roxanne Mayo, for one half (1/2) of the monthly costs of the Respondent to continue the parties' minor children on her insurance. The Petitioner, Richard A. Mayo, has failed to comply with this court order.

10. The Court further ordered that in order to purge himself of contempt the Petitioner, Richard A. Mayo, at the hearing on September 7, 1993, was to sign a Quit Claim

Deed transferring all of his interests in the parties' real estate to the Respondent, Roxanne Mayo. The Petitioner, Richard A. Mayo has failed and refused to comply with this order of court.

11. For all of the above reasons the Court finds the Petitioner, Richard A. Mayo, is in contempt of court. The Court sentences the Petitioner, Richard A. Mayo, to ninety (90) days in the Lake County Jail, said jail sentence to begin instant. The Court further issues a warrant for the arrest of Richard A. Mayo, 2924 A. 177th Street, Apt #810, Hammond, 46323. Richard A. Mayo's date of birth is May 2, 1953, and his social security number 286-54-6962.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that the Petitioner, Richard A. Mayo, is in contempt of this court for failing to comply with the orders of this court.

IT IS FURTHER ORDERED by the Court that the Court appoint Kenneth L. Anderson as Commissioner and orders said Commissioner to execute a Quit Claim Deed transferring all of the interest of the Petitioner, Richard A. Mayo, in the parties' real estate located at 7151 Woodlawn Avenue, Hammond, Indiana 46324 to the Respondent, Roxanne C. Mayo.

The Court sentences the Petitioner, Richard A. Mayo, to ninety (90) days in the Lake County Jail. The Court issues a warrant for the arrest of Richard A. Mayo, 2924 A. 177th Street, Apt #810, Hammond, Indiana, 46323, date of birth May 2, 1953, social security number 286-54-6962.
