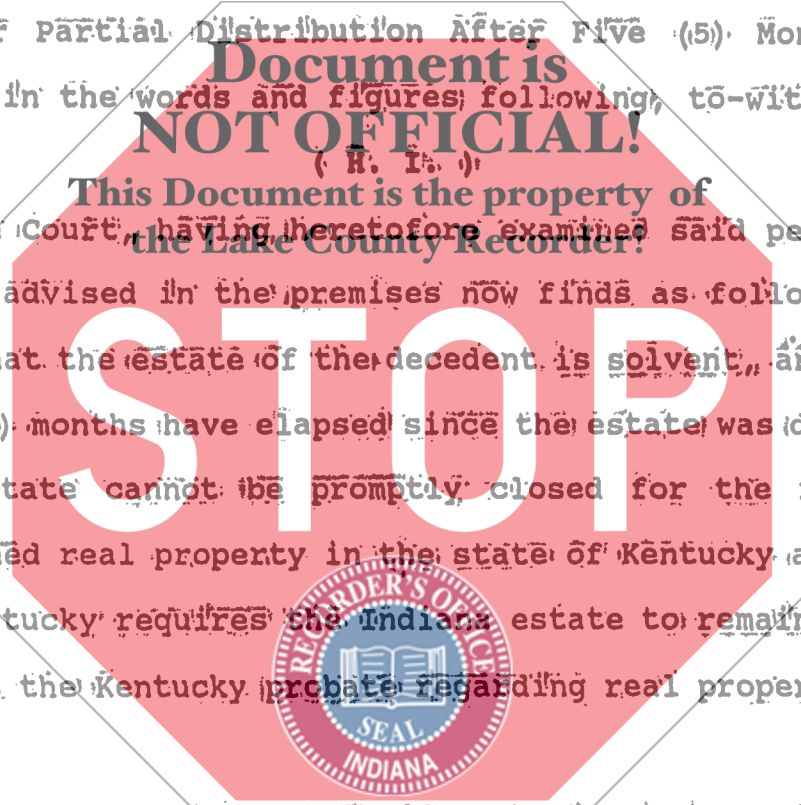

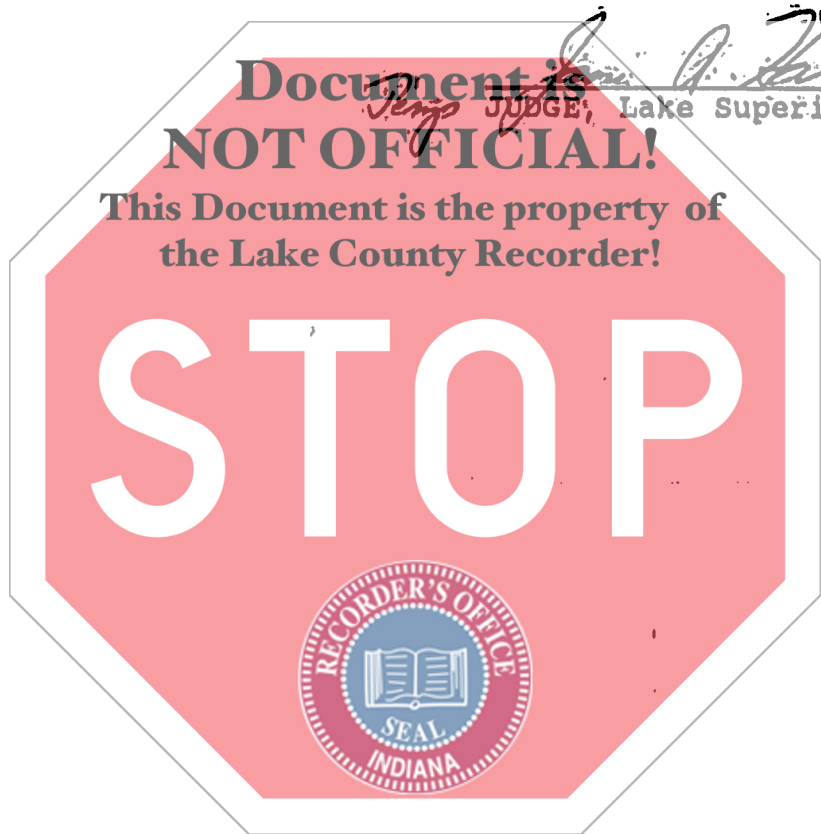

3. That said distributees shall not be required to furnish security for the property being distributed, however, said distribution is conditional upon the return of the property.

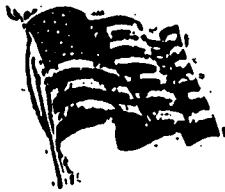

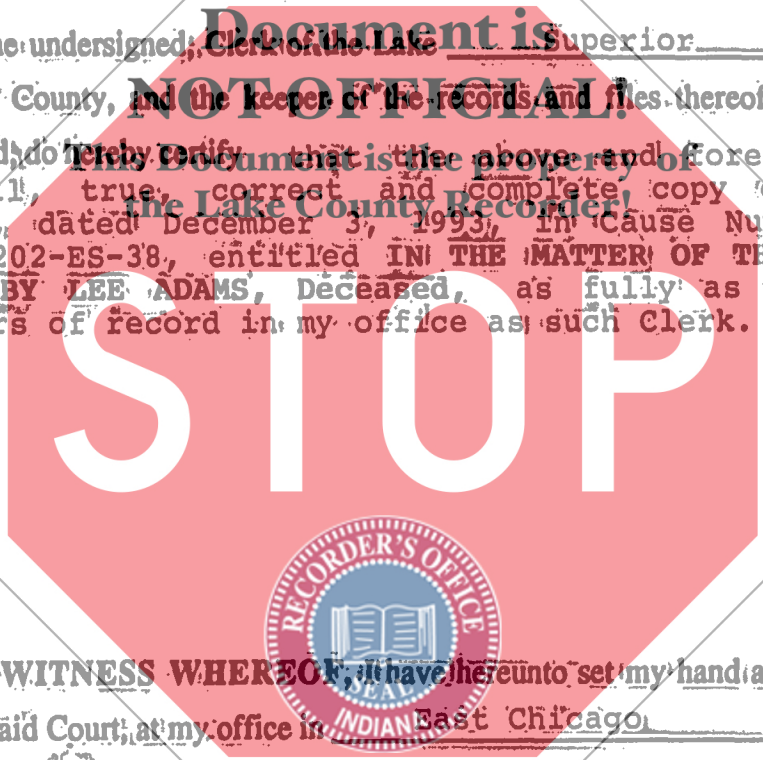

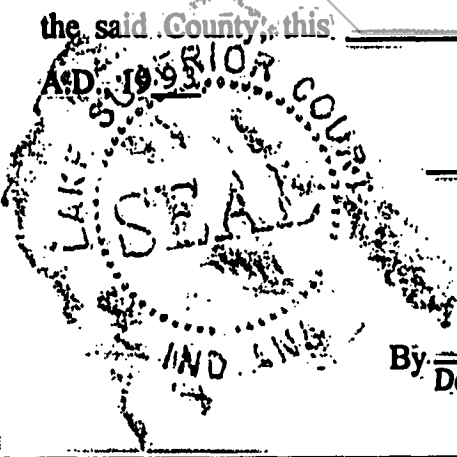
