does hereby grant, bargain, sell and convey to:

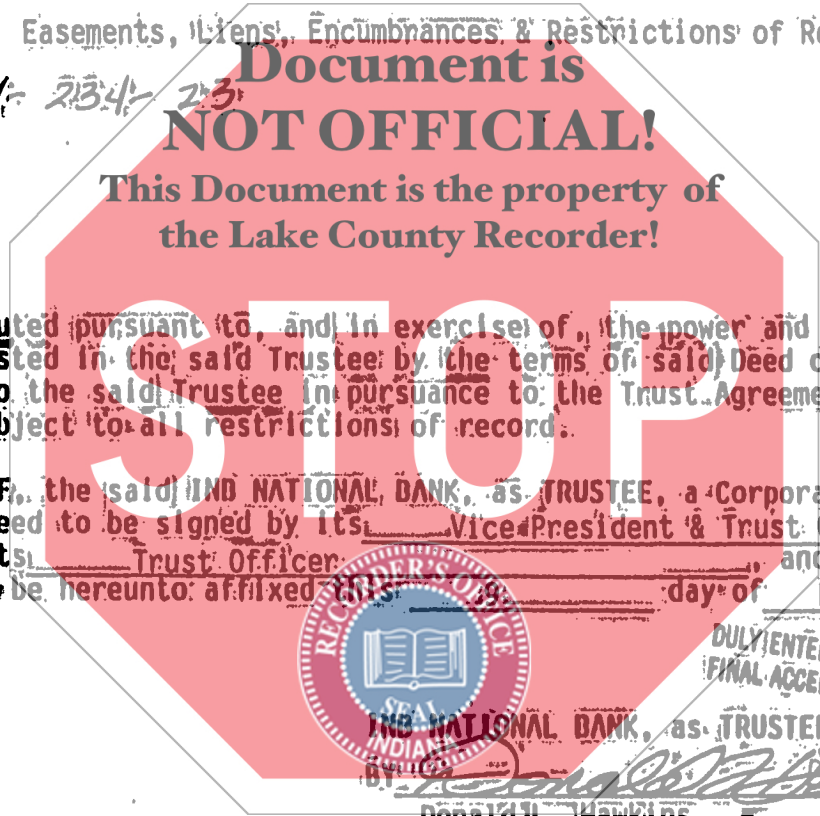
