AFFIDAVIT AS TO

Richard A. Jastrzebski, being first duly sworn upon oath, deposes and says:

That he is an adult and the named Executor of the Estate of Anthony Jastrzebski, who died on Aug. 23, 1992.

That he has personal knowledge that the decedent, Wanda Jastrzebski and her husband, Anthony (a/k/a Antoni) Jastrzebski, were owners by the entireties of the following, described real estate, to wit:

Lots 25 and 26, Block 6, subdivision of the East 1510.2 feet of the North, 1320 feet of the Northwest Quarter of Section 32, Township 37 North, Range 9 West of the 2nd P.M., except the East 201 feet thereof, in the City of East Chicago, as shown in Plat Book 2, Page 16, in Lake County, Indiana (commonly known as 1018 W. 151st St., East Chicago, IN).

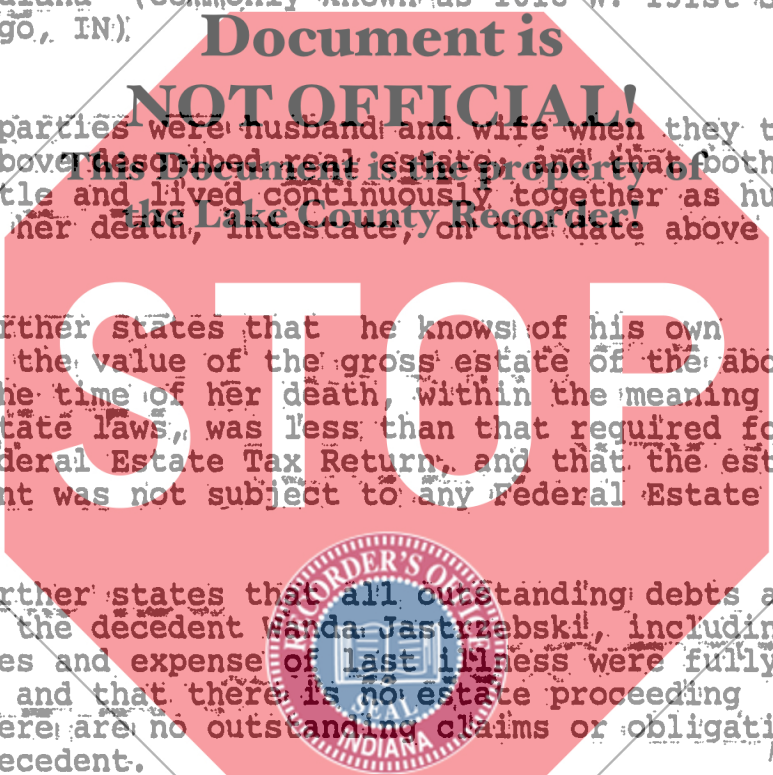
