To do any and all acts necessary to close the property located in Highland, Indiana,, more particularly described as follows:

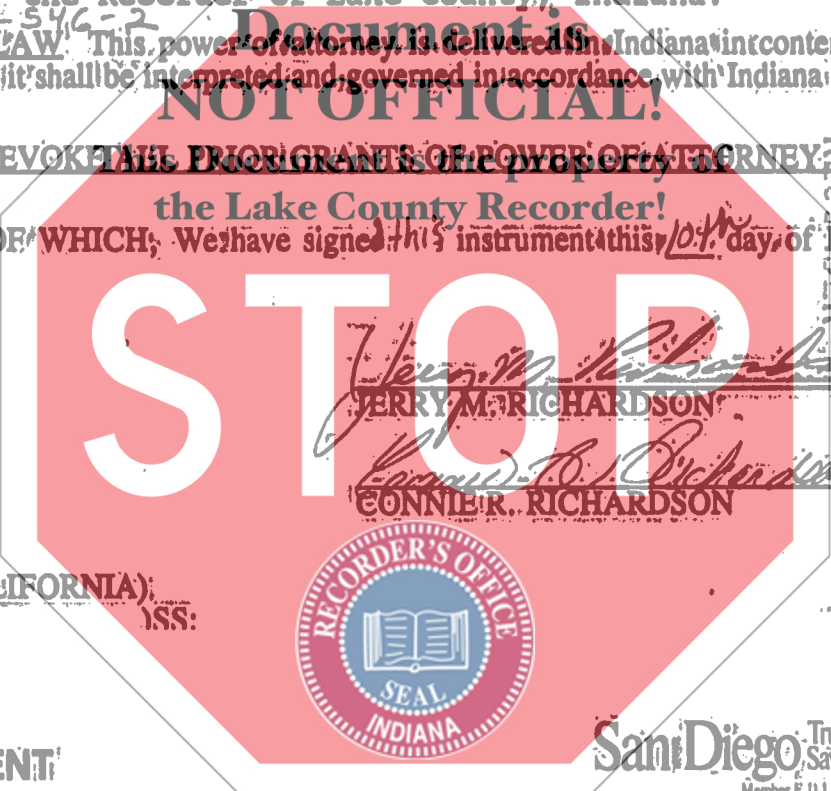

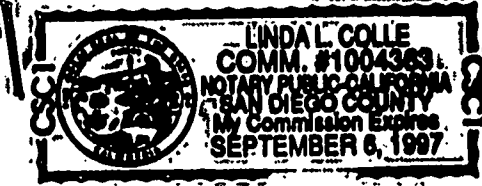
