THIS INDENTURE WITNESSETH, that the Grantor, R. BERENIECE McLEAN of Lake County, Indiana, for and in consideration of the sum of Ten (\$10.00) Dollars, and other good and valuable consideration, the receipt of which is hereby acknowledged, conveys and warrants to R. BERENIECE MCLEAN, as Trustee, under the provisions of that certain trust Agreement dated the 26th day of October, 1993, and known as the R. to have and to hold the said real estate with the appurtenances, upon the trusts, and for the uses and purposes herein and in said Trust Agreement set forth.
