4470 Guadalupe Circle, East Chicago, Indiana

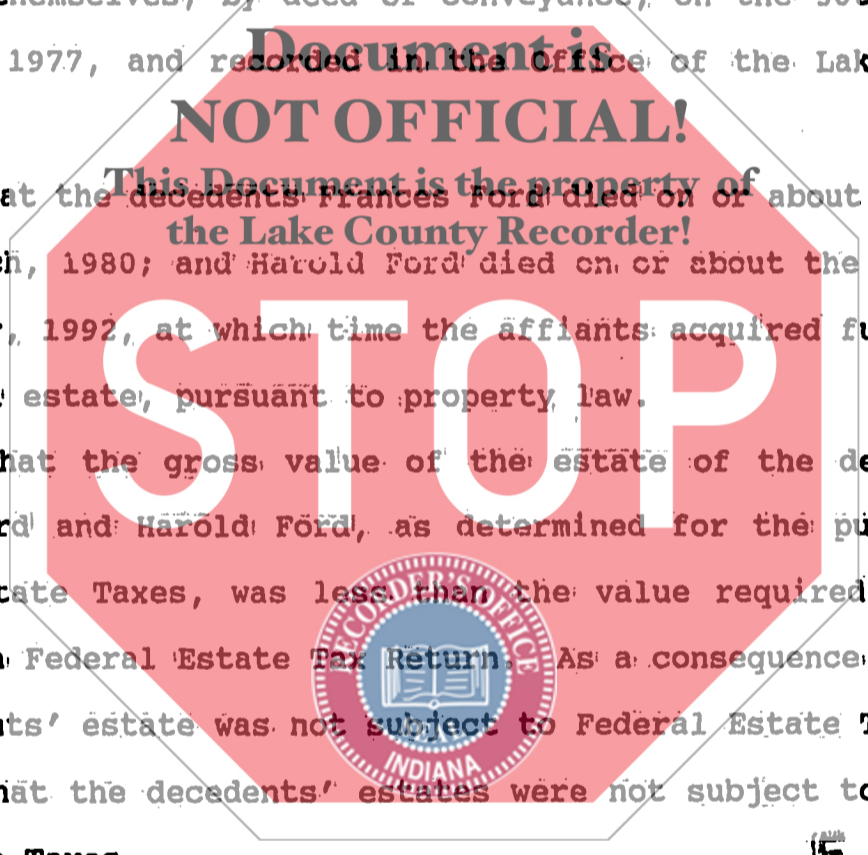

As a consequence thereof, the decedents' estate was not subject to Federal Estate Tax.

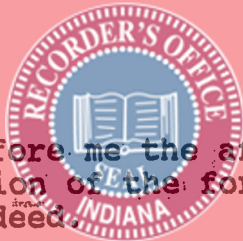
