Comes now LEONARD A. HAMRLIK, being duly sworn upon his oath, and states as follows:

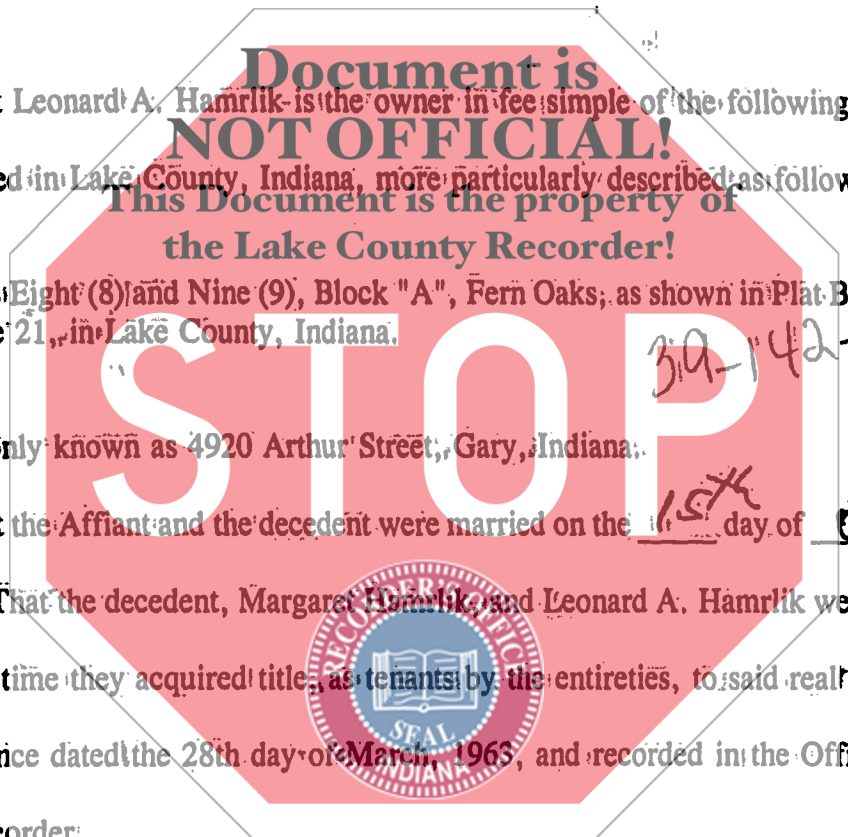
That Leonard A. Hamrlik is the owner in fee simple of the following described real estate located in Lake County, Indiana, more particularly described as follows:

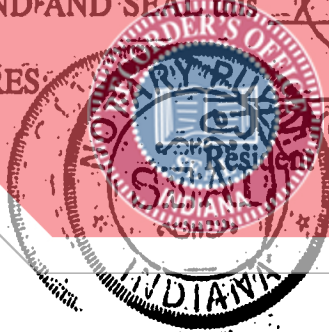
