3.e. INSURANCE. Authority with respect to any and all insurance transactions pursuant to IC 30-5-5-7 provided that such insurance involves and concerns the real and personal property commonly known as 7714 Virginia Place, Merrillville, Indiana 46410.

3.f. RECORDS, REPORTS AND STATEMENT. Authority with respect to any records, reports and statements involving the real and personal property commonly known as 7714 Virginia Place, Merrillville, Indiana 46410, pursuant to IC 30-5-5-14.

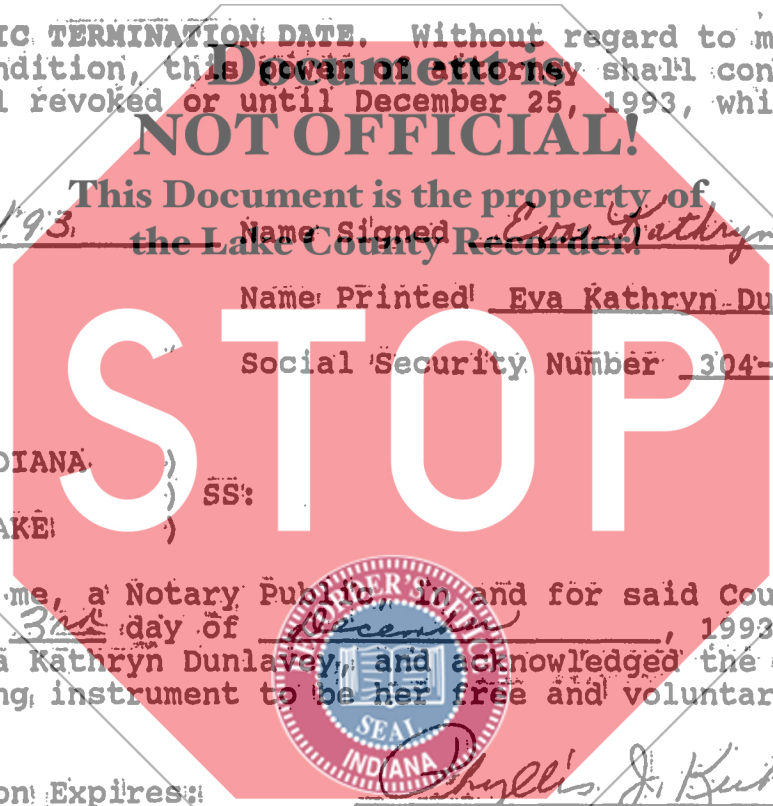

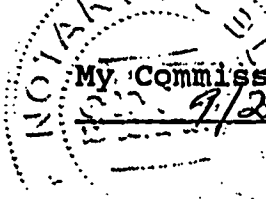
