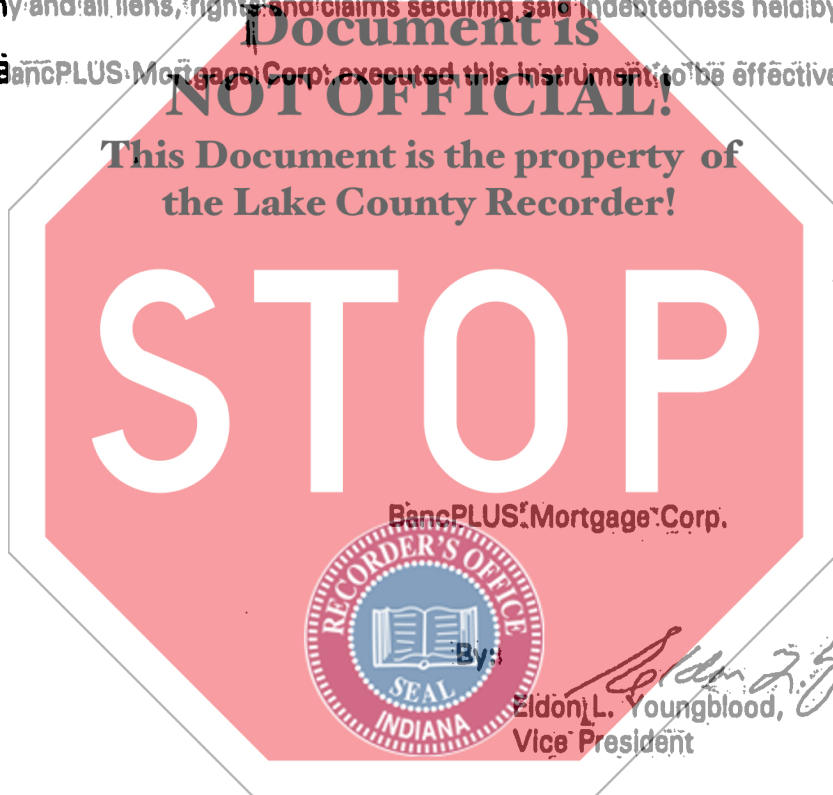
Satisfaction of Mortgage

In Witness Whereof, BancPLUS Mortgage Corp. executed this instrument to be effective as of October 6, 1993.



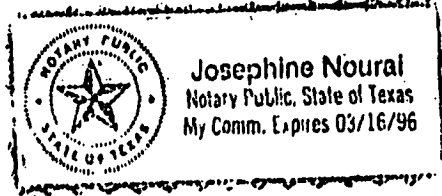
