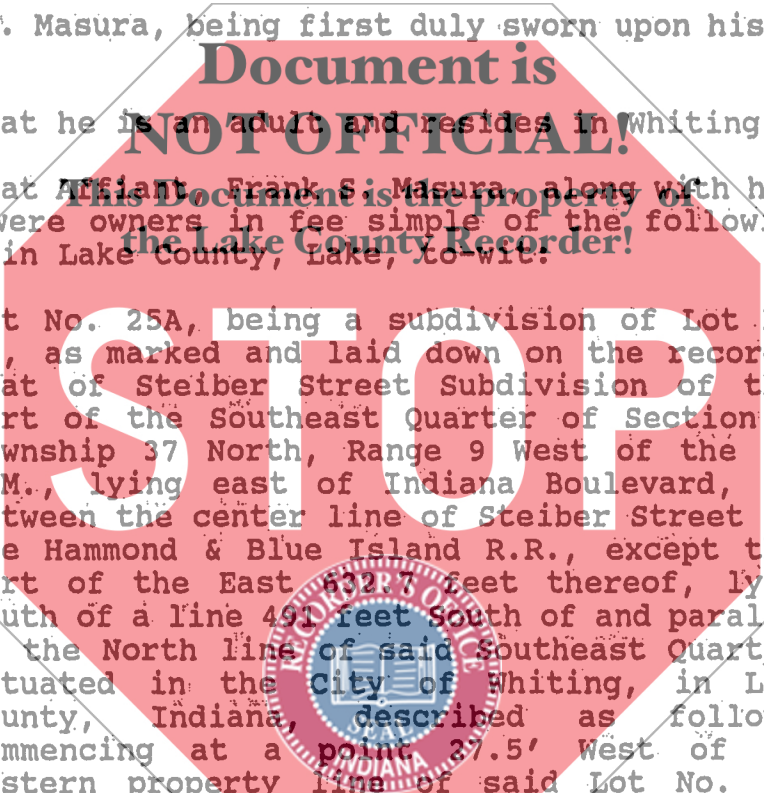
AFFIDAVIT OF SURVIVORSHIP

3. That Frank S. Masura and Mary M. Masura, were Husband and Wife at the time they acquired title to the above-described real estate and so remained until the death of Mary M. Masura on November 4, 1989, and they were never divorced.
