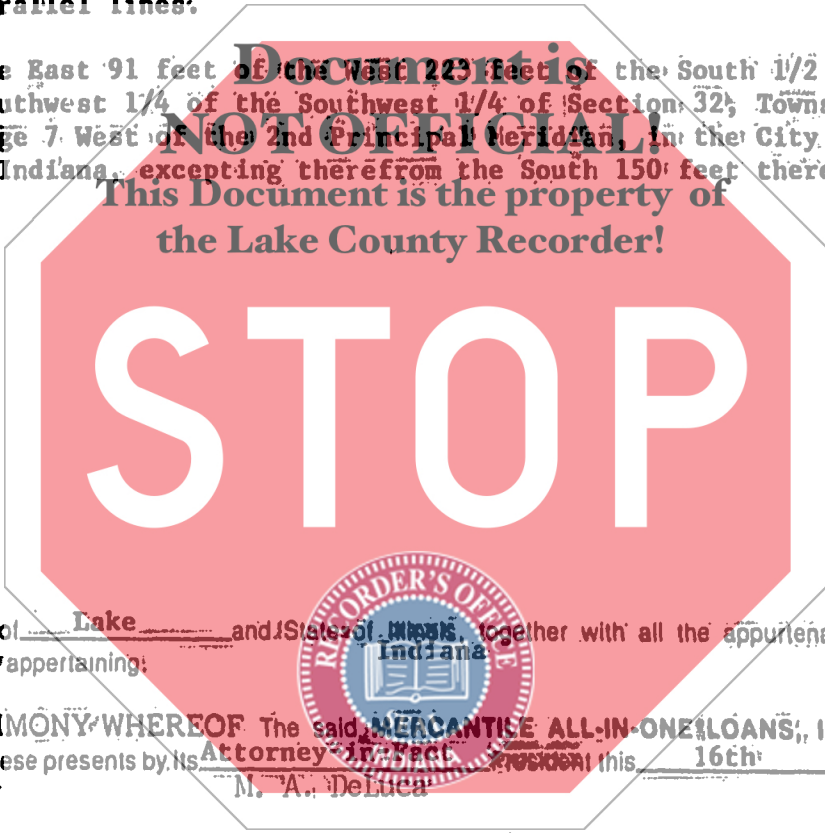
RELEASE DEED

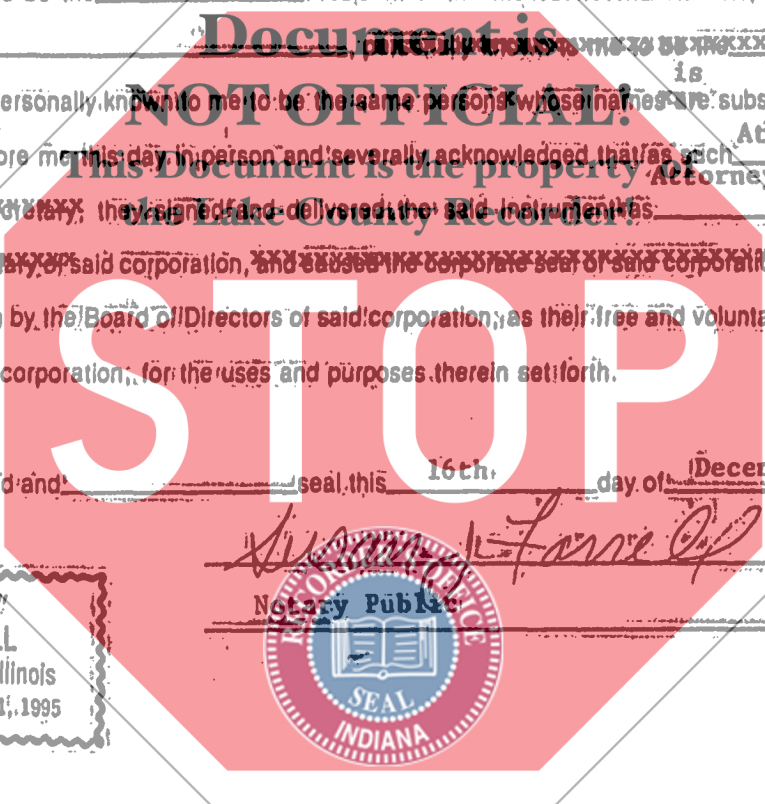

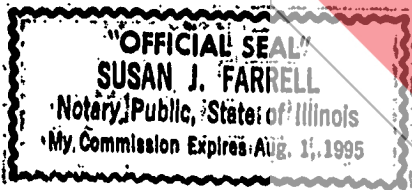
