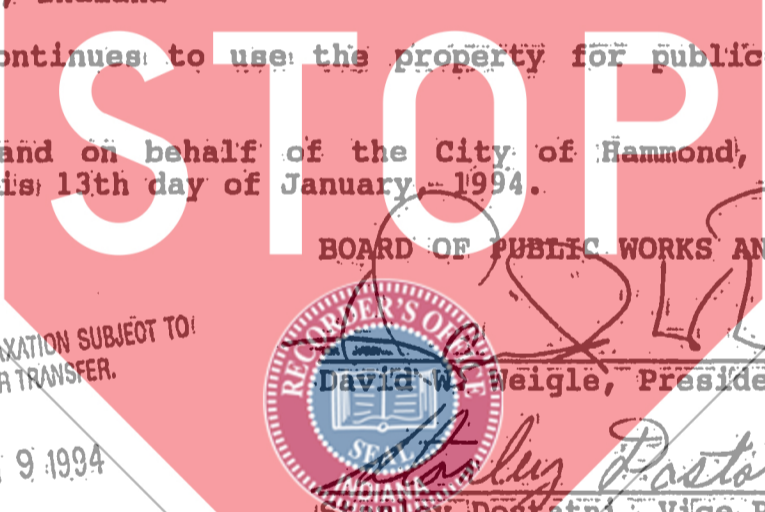

A part of the northwest quarter of the northwest quarter of Section 115, Township 36 North, Range 9 west of the second principal meridian and more particularly described as commencing at a point in the centerline of Black Oak Road, 930.2 feet southeasterly measured along said centerline, from the west line of said section thence north parallel with the west line of said section 110.2 feet; thence east parallel with the north line of said section, 51 feet; thence south parallel with the west line of Section 15, 440 feet, more or less, to the centerline of Black Oak Road; thence northwesterly 50 feet to the place of beginning, containing one-half acre more or less, in the City of Hammond, Lake County, Indiana
