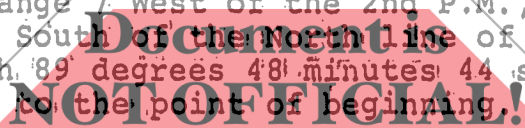

THIS INDENTURE WITNESSETH that Vera C. Lytle of Lake County, State of Indiana, RELEASES and QUIT-CLAIMS to Vera C. Part of the East 2/3rd of the Northeast quarter of the Northeast quarter of Section 20, Township 34 North, Range 7 West of the 2nd P.M., Lake County, Indiana, described as follows: Beginning at a point on the East line of said Section 20 and 299.26 feet South of the Northeast corner thereof, said point being the Northeast corner of the South 7 acres of the North 13 acres of said East 2/3rds; thence South 00 degrees 34 minutes 20 seconds East along the East line of said Section 20 a distance of 260 feet; thence South 89 degrees 48 minutes 44 seconds West, 880.84 feet to the West line of said East 2/3rds; thence North 00 degrees 31 minutes 04 seconds West along the West line of said East 2/3rds a distance of 260.0 feet to the Northwest corner of the South 7 acres of the North 13 acres of the East 2/3rds of the Northeast quarter of the Northeast quarter of Section 20, Township 34 North, Range 7 West of the 2nd P.M., said point being 299.64 feet South of the North line of said Section 20; thence North 89 degrees 48 minutes 44 seconds East, 880.59 feet to the point of beginning.
