This Deed of Release Witnesseth, That:

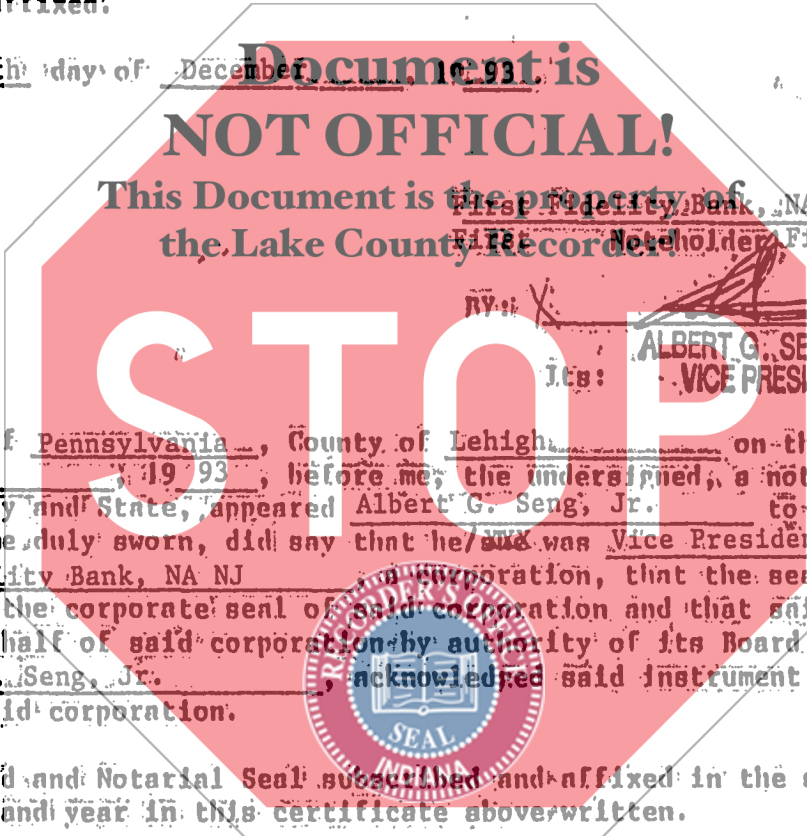
