NOW THEREFORE, the conditions of this bond are such that if the said Principal shall well and faithfully pay the wages, expense allowances, Savings Plan, Working Dues or Assessment deductions; Welfare Fund, Pension Fund, Apprentice Training Fund, Industry Promotion Fund, Special Account and Legal Fund contributions and any other financial obligations authorized or required by the abovereferred to Collective Bargaining Agreement due to be paid to or on behalf of any and all Union members or other employees working within the jurisdiction of the Union named above pursuant to the provisions of the said Collective Bargaining Agreement and in the employ of the Principal, then this obligation shall be void, otherwise the same shall remain in full force and effect. It is expressly understood and agreed that the Principal and Surety shall become obligated to pay such wages, expense allowances, Savings Plan, Working Dues or Assessment deductions; Welfare Fund, Pension Fund, Apprentice Training Fund, Industry Promotion Fund, Special Account and Legal Fund contributions and other financial obligations required by the Collective Bargaining Agreement as are due and unpaid within fourteen (14) days of the receipt of notice or filing of evidence with the Surety of the delinquency in payment of the above obligations by the Employer, herein referred to as the Principal. It is further expressly understood and agreed that the liability of the Principal and Surety in this connection shall be limited to the unpaid wages and expenses accrued within the one hundred twenty (120) days immediately prior to the last date of employment of each employee and to the unpaid Savings Plan, Working Dues or Assessment deductions; Welfare Fund, Pension Fund, Apprentice Training Fund, Industry Promotion Fund, Special Account and Legal Fund contributions and other financial obligations required by the Collective Bargaining Agreement accrued within one hundred eighty (180) days immediately prior to the last date of employment of each employee, and in no case shall the aggregate liability of the Principal and Surety exceed the sum of Ten Thousand Dollars (\$10,000). IT IS FURTHER expressly understood and agreed that this Employers Surety Bond and the obligations appertaining thereto shall remain in full force and effect and be binding upon the parties hereto during each successive Agreement, if any, entered into by and between the Union and the abovenamed Principal unless no such successive Agreement is entered into between the Union and the Principal at the expiration of the current Agreement between the parties. In no event shall the Principal herein be relieved of the obligations contained in the bond during the period in which an Agreement remains in effect between the parties hereto. This Bond may be cancelled by the Surety sixty (60) days after receipt by the Obligee of the Surety's written notice of cancellation sent by Registered Mail.
