And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

- Due notices of the filing of said account and petition and of the hearing on the same were given to all persons Interested in said estate, and the same are now properly before the court for final action thereon.
- That John A. Hughes, died testate, a resident of the County of Lake, State of Indiana, on the 14th day of March, 1986, and his Last Will and Testament was duly admitted to probate before this court on the 21st day of May, 1986, and this court appointed Rose Hughes as executrix of the Last Will and Testament of the decedent, and said executrix was issued Letters of Testamentary on the 21st day of May, 1986, to her; that sald executrix was removed and replaced by successor executrix Mila Rock who qualified and was issued Letters Testamentary on the 19th day of May, 1992.
- That the matters and things stated in said account and petition are true, and that said executrix has accounted for all the assets in said estate coming into her hands.
