This matter was set for a hearing on the plaintiff's Motion for Summary Judgment. The plaintiff appeared by counsel, Kenneth M. Wilk. Defendant, Ora Pearson, appeared pro se. Defendant's counsel, Kevin Relphorde, advised the Court that he was en route to the court house. This matter was adjourned for approximately one hour to allow Mr. Relphorde to arrive at the court house.

At 3:35 p.m. when Mr. Relphorde had not arrived, this matter resumed. The plaintiff requested the Court to go forward on it's motion. Defendant requested a continuance to obtain new counsel. Since defendant was once earlier granted a continuance to obtain counsel, and since no counsel appeared at the status conference on December 6th, 1993, and Mr. Relphorde having not contacted the Court to indicate any reason for his failure to appear at this time, the Court now finds that the plaintiff's Motion for Continuance should be Denied.

Thereupon the cause was submitted on the plaintiff's Motion for Summary Judgment and the Court now finds that plaintiff is entitled to judgment as a matter of law.

IT IS NOW, THEREFORE, ORDERED, ADJUDGED AND DECREED that the plaintiff, IDS Amex Insurance Company recover or and from the defendant, Ora Pearson, the sum of \$36,000.00 together with the costs of this action.

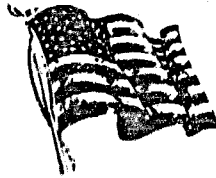
