KNOWN ALL MEN BY THESE PRESENTS: That

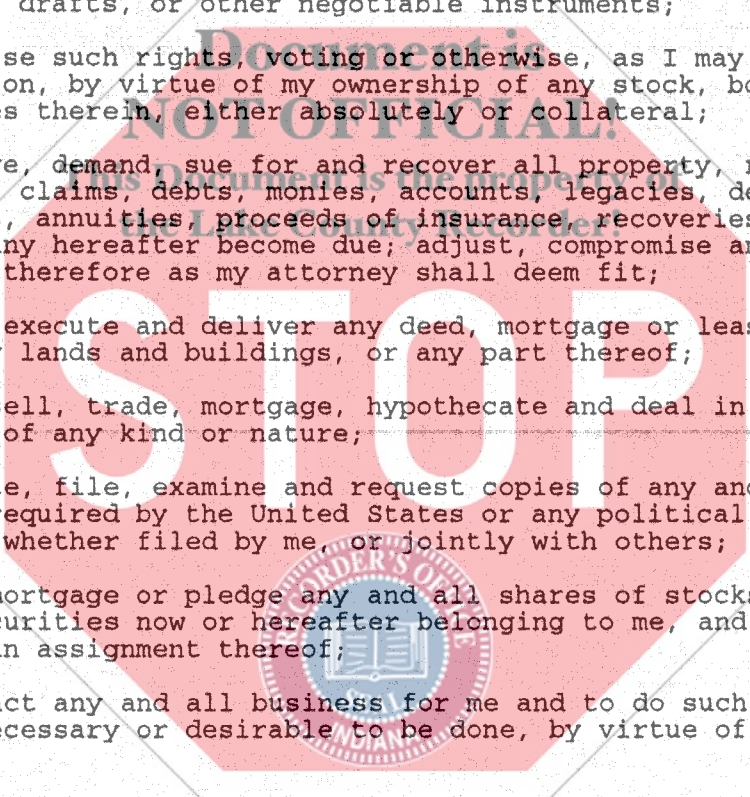
I, Lisa Roy Billodeau of the City of Denham Springs Parish of Livingston and the State of Louisiana

DO HEREBY MAKE, CONSTITUTE and APPOINT Dewey David Billodeau, Jr. of the City of Crown Point County of Lake and the State of Indiana my true and lawful attorney, for me and in my place and stead, with full power of substitution,

8. to sell mortgage or pledge any and all shares of stocks, bonds or other securities now or hereafter belonging to me, and to execute and deliver an assignment thereof;
9. to transact any and all business for me and to do such other acts as may be necessary or desirable to be done, by virtue of this power of attorney.
