MEMORANDUM OF LEASE Acres 22. 12.

This is the Memorandum of that certain unrecorded Lease dated Beamber 31, 1993, between DONALD S. POWERS, as "Lessor", and UNITED STATES POSTAL SERVICE, as "Lessee", concerning the premises described as:

Approximately 4,808 square feet contained in a one story masonry building located on real estate in the Town of Munster, Lake County, Indiana described as follows:

Market Square Commercial Complex as per plat thereof, in the Office of the Recorder of Lake County, Indiana more commonly known as 915 Ridge Road, Munster, Indiana.

For good and valuable consideration, Lessor leases the premises to Lessee, and Lessee rents the same from Lessor for a term of five (5) years commencing January 1, 1994, and expiring December 31, 1998, all in accordance and under the provisions contained in the above-mentioned unrecorded Lease, which unrecorded Lease is incorporated in this Memorandum by reference.

Said Lease further provides that Lessee shall have the use of the following areas for the parking of postal vehicles: on the north end of the building immediately adjoining the dock area to include approximately three thousand five hundred (3,500) square feet of driveway and maneuvering area and including twelve (12) parking spaces on the north side of the building and seven (7) parking spaces on the east side of the building.

Said Lease does further contain provisions defining the responsibilities of the Lessor and Lessee.

This Memorandum is not a complete summary of the Lease. Provisions in the Memorandum should not be used in interpreting the Lease provisions. In the event of conflict between the Memorandum and the unrecorded Lease, the unrecorded Lease shall control.
