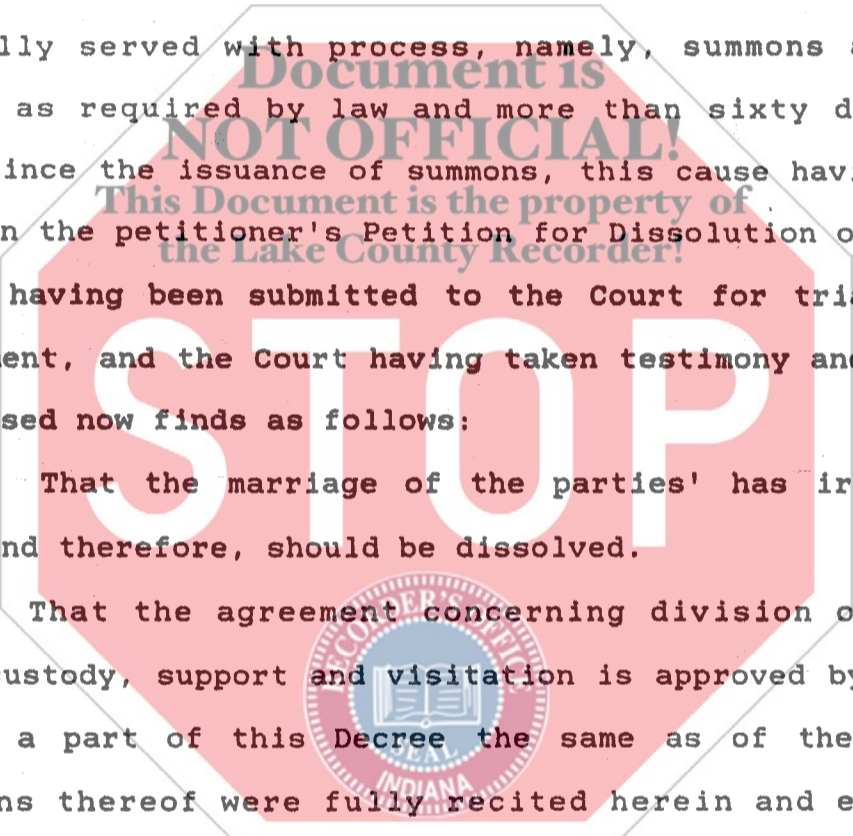

2. The marital Property Settlement Agreement of the parties is hereby approved, made a part of this decree and incorporated herein by reference.

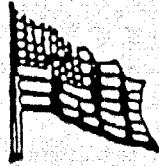
3. That the petitioner's maiden name of DORSEY is hereby restored.

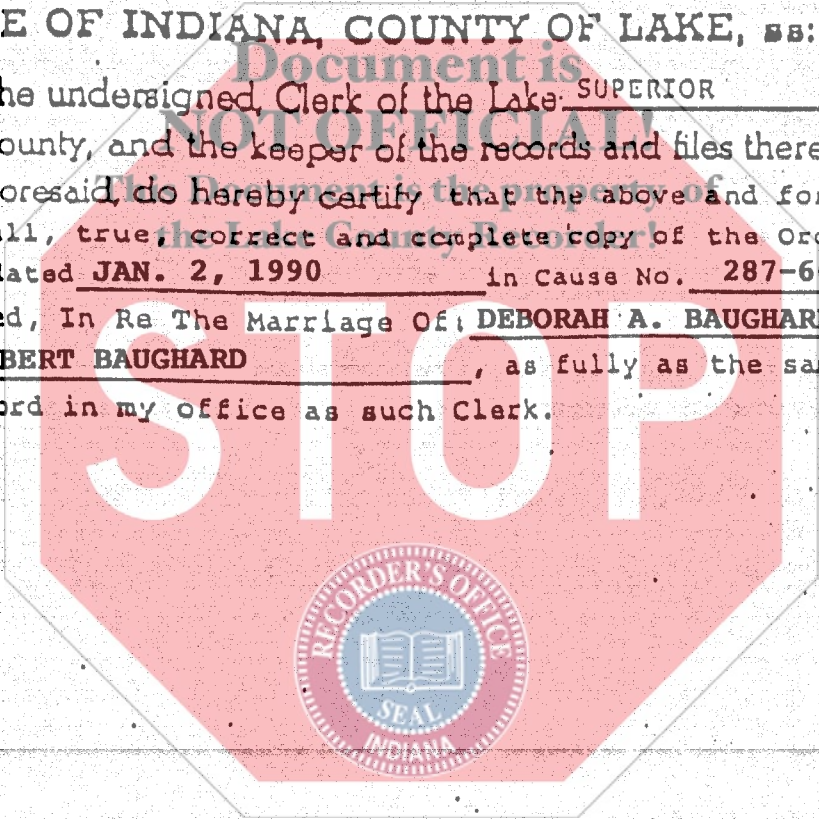
