hereby ratifying all that my (our) said attorney shall lawfully do or cause to be done by virtue of these presents.

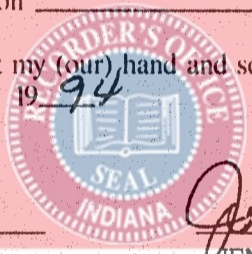
And I (we) hereby declare that any act or thing lawfully done hereunder by my (our) said attorney shall be binding on me (us)
