- (1) Continue, modify, or terminate a deposit account or other banking arrangement made by or on behalf of the principal before the execution of this Power of Attorney;
- (2) Open in the name of the principal alone, or in a way that clearly evidences the principal and attorney in fact relationship, a deposit account with a bank, trust company, savings and loan association, credit union, thrift company or other institution that serves as a depository for funds selected by the attorney in fact;
- (3) Make sign, and deliver checks or drafts for any purpose and withdraw by check, order, or other means funds or property of the principal deposited with or left in the custody of a banking institution either before or after this Power of Attorney was executed;
- (4) Prepare necessary financial statements of assets and liabilities or income and expenses of the principal for submission to a banking institution;
- (5) Receive statements, vouchers, notices or other documents from a banking institution and act with respect to the documents;
- (6) Make, draw and endorse promissory notes, checks or bills of exchange and to waive demand, presentment, protest, notice of protest, and notice of non-payment of all such instruments
- (7) Receive and demand all sums of money, debts, dues, accounts, bequests, interest, dividends, and demand whatsoever which are now or shall hereafter become due or payable to me and to compromise or discharge the same;
- (8) Sell, mortgage, convey and lease any and all of my interest in the following real estate:

A part of the Northeast quarter of the Northwest quarter of Section 15, Township 35 North, Range 8 West of the Second P.M., described as: commencing at a point which is 420 feet East and 213 feet South of the Northwest corner of said quarter quarter section, thence South 153 feet, thence East 100 feet, thence North 153 feet, thence West 100 feet, to the place of beginning, in Lake County, Indiana.

and I hereby ratify and confirm all that my said attorney in fact or agent shall do by virtue hereof.

(9) Any and all other powers specifically set forth in Indiana Code 30-5-5-2 that are not specifically set forth herein.

I hereby reserve the right of revocation; however, this Power of Attorney shall continue in full force and effect until June 30, 1994. I further state that this Power of Attorney shall NOT be affected by my incompetence.
