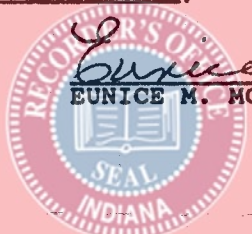
An undivided one-quarter interest in and to the following described real estate:

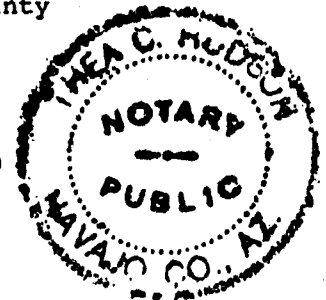
