

Trustee's Deed

This indenture witnesseth, That GARRETT J. KNESEK, as Successor Trustee under the Trust Agreement dated July 8, 1988 and known as The Knesek Family Trust, of Lake County, and State of Indiana, does hereby grant, bargain, sell and convey to: RICHARD L. FITZSIMONS, JR. of Lake County, in the State of Indiana for the sum of Ten Dollars (\$10.00) and Other Good and Valuable Consideration, the following described Real Estate in Lake County, in the State of Indiana, to-wit:

That part of the Northwest 1/4 of Section 8, Township 34 North, Range 8 West of the 2nd Principal Meridian, in Lake County, Indiana, described as follows: Beginning at a point on the South line of the Northwest 1/4 of said Section 8, said point being 2 chains and 2 links (133.32) feet) West of the Southwest corner of Eddy's First Addition to Crown Point; thence West along said South line a distance of 15.15 feet to an iron pipe 25 chains 70 1/2 links (1696.53) feet East of the Southwest corner of said Quarter section; thence North a distance of 462 feet to an iron pipe; thence East a distance of 15.15 feet to an iron pipe; thence South parallel to the West line of Eddy's First Addition and 2 chains and 2 links West of said West line a distance of 285 feet; thence East a distance of 66.66 feet; thence South a distance of 177 feet to the South line of the Northwest 1/4 of said Section 8; thence West along said South line a distance of 66.66 feet to the place of beginning, except the West 15.15 feet of, the North 285 feet.
