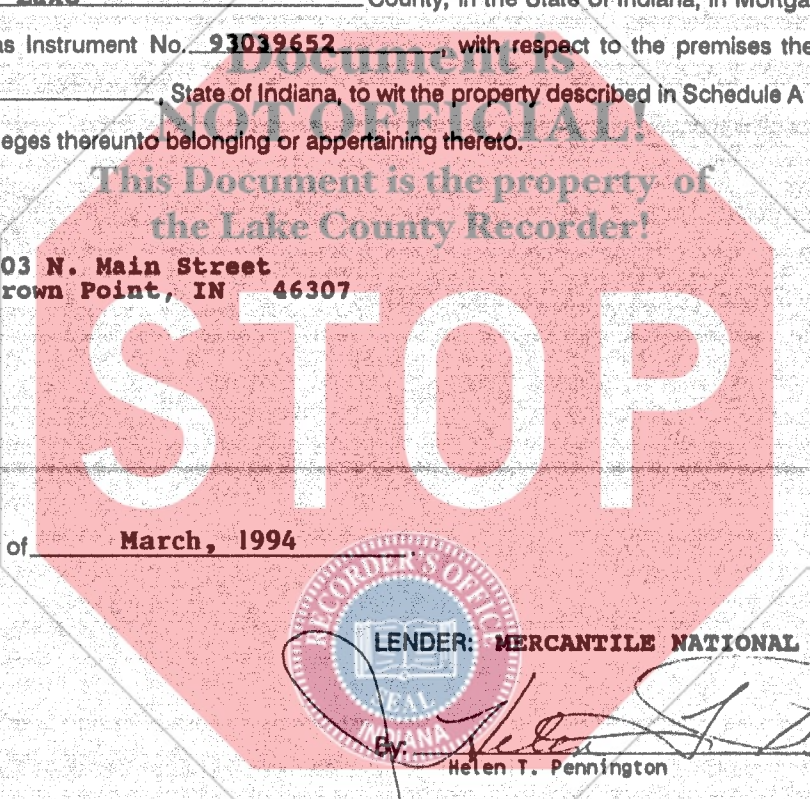

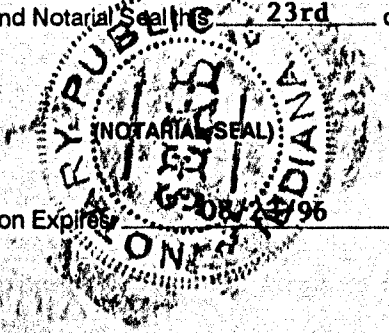

SCHEDULE A

Parcel 1: Part of the Northeast Quarter of the Southwest Quarter of Section 5, Township 34 North, Range 8 West of the Second Principal Meridian, described as follows: Beginning at a point on the West Line of Main Street which is 165 feet North of the South Line of said 40 acre tract and running thence West 110 feet, thence South 66 feet, thence East 110 feet, thence North 66 feet to the place of beginning, in the City of Crown Point, Lake County, Indiana.

Parcel 2: Part of the Northeast Quarter of the Southwest Quarter of Section 5, Township 34 North, Range 8 West of the Second Principal Meridian, in the City of Crown Point, Lake County, Indiana, described as follows: Beginning at a point 165 feet North of the South Line of said 40 acre tract and 110 feet West of the West line of Main Street, thence West 20 feet; thence South 66 feet; thence East 20 feet; thence North 66 feet to the point of beginning, in Lake County, Indiana.
