- 3. PURPOSE, This Mortgage and the Obligations described herein are executed and incurred for consumer purposes.
- 4. FUTURE ADVANCES. Pursuant to Indiana Code Section 32-8-11-9, future obligations, advances, modifications, extensions, and renewels of any indebtedness made up to the maximum amount secured by this mortgage shall be secured to the same extent as if the future obligations, advances, modifications, extensions and renewals were made on the date of execution of the mortgage. - 10. USE AND MAINTENANCE OF PROPERTY. Grantor shall take all actions and make any repairs needed to maintain the Property in good condition. Grantor shall not commit or permit any waste to be committed with respect to the Property. Grantor shall use the Property solely in compliance with applicable law and insurance policies. Grantor shall not make any alterations, additions or improvements to the Property without Lender's prior written consent. - 21. RIGHTS OF LENDER ON DEFAULT. If there is a default under this Mortgage, Lender shall be entitled to exercise one or more of the following remedies without notice or demand (except as required by law):
  - (a) to terminate or suspend further advances or reduce the credit limit under the promissory notes or agreements evidencing the obligations;
  - (b) to declare the Obligations immediately due and payable in full;

  - (d) to require Grantor to deliver and make available to Lender any personal property constituting the Property at a place reasonably convenient to Grantor and Lender;

  - (i) to set-off Grantor's Obligations against any amounts due from Lender including, but not limited to, monies, instruments, and deposit accounts maintained with Lender; and

- 22. APPLICATION OF FORECLOSURE PROCEEDS.
