by serving written notice upon the Obligee thirty (30) days in advance of its intention to do so.

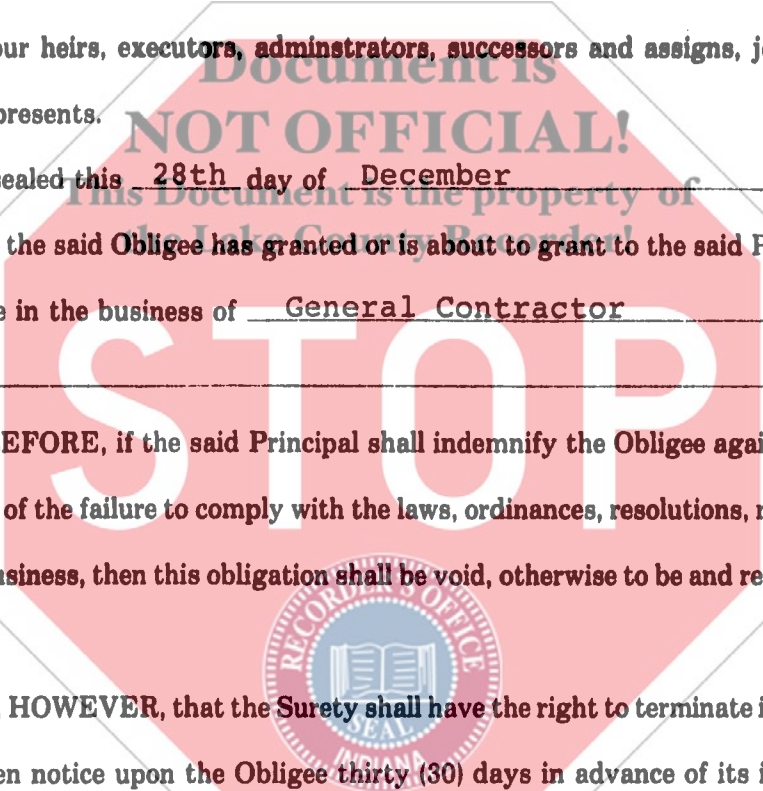

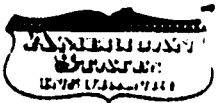
