follows:

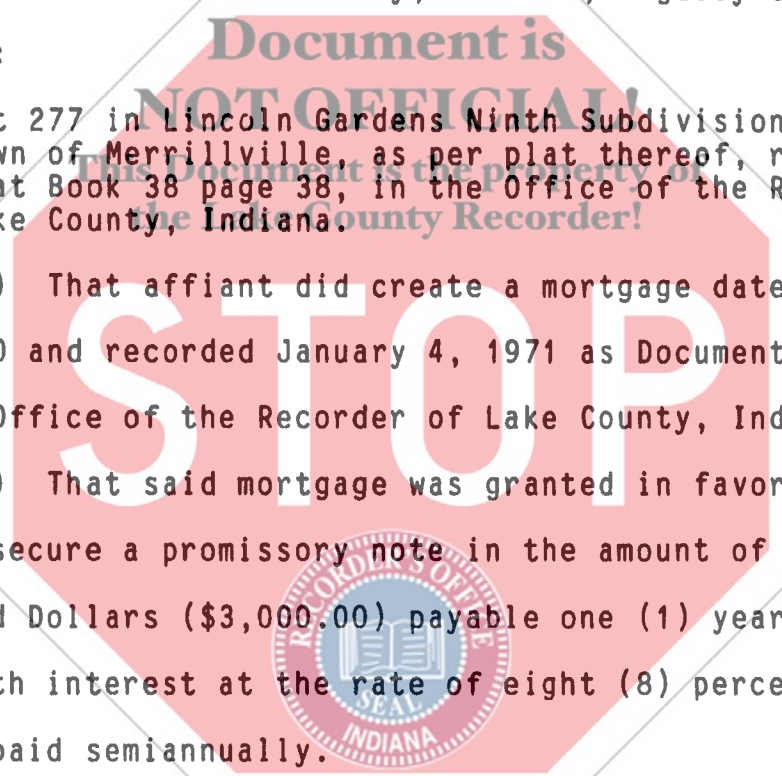
Lot 277 in Lincoln Gardens Ninth Subdivision, in the
