To pay any and all expenses incident to my care, support, health, welfare and maintenance, or required to discharge any obligation, account, tax or other indebtedness for which I am responsible; and

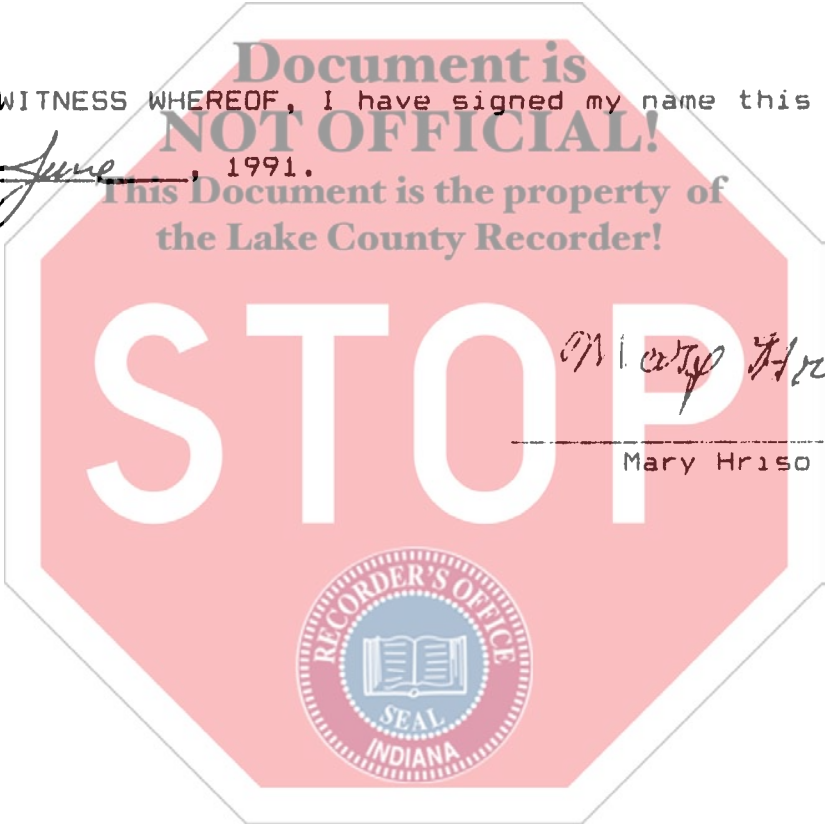
To employ agents or other persons in connection with the performance of these delegated powers as my attorney shall see fit; and


