Hortgagor represents and agrees that no rent has been or will be paid by any portion of the Property for more than one installment in advance and that the payment of none of the rente to secrue for any portion of the said Property has been or will be waived, released, reduced, discounted or otherwise discharged or compromised by the Hortgagor. Hortgagor waives any right of set off against any person in possession of any portion of the Property. Mortgagor agrees not to further assign any of the rents or profits of the Property.

Nothing herein contained shall be construed as constituting the Hortgagee a mortgagee in possession in the absence of the taking of actual possession of the Property by the Hortgages. In the exercise of the powers herein granted Mortgages, no liability shall be asserted or enforced against Mortgagee, all such liability being expressly waived and released by Mortgagor.

Mortgager futher earese to seeign and transfer to Mortgages, by separate written instrument all future lesses upon all or any part of the Property and to execute and deliver, at the request of the Mortgages, all such further assurances and assignments as Hortzages shall from time to time require.

All leases affecting the Property shall be submitted by Mortgagor to Hortgages for its approval prior of the execution thereof. All approved and executed leases shall be specifically assigned to Mortgages by instrument in form satisfactory to Hortgagee.
