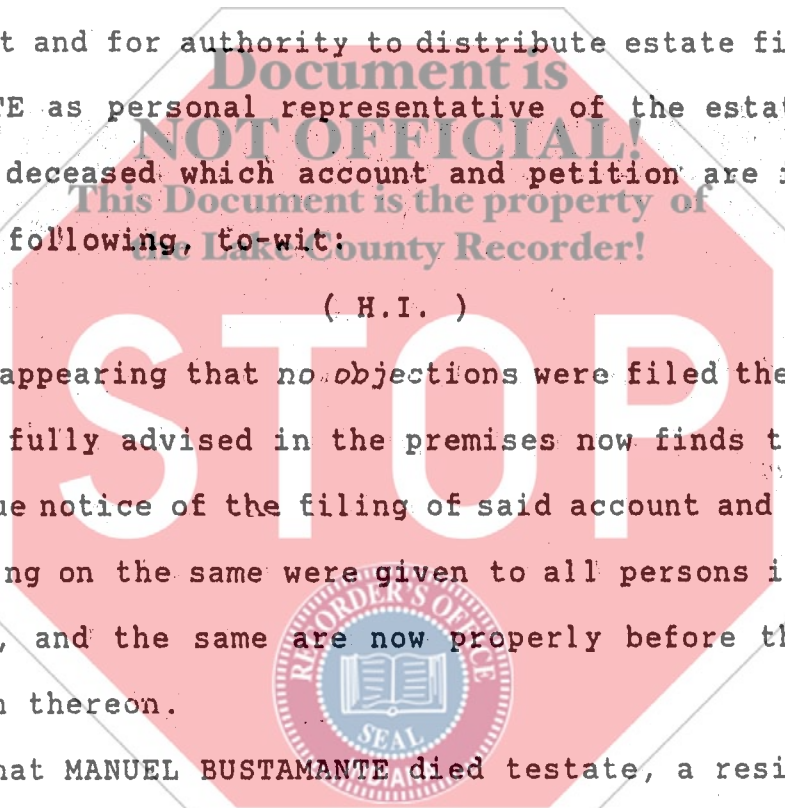

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as

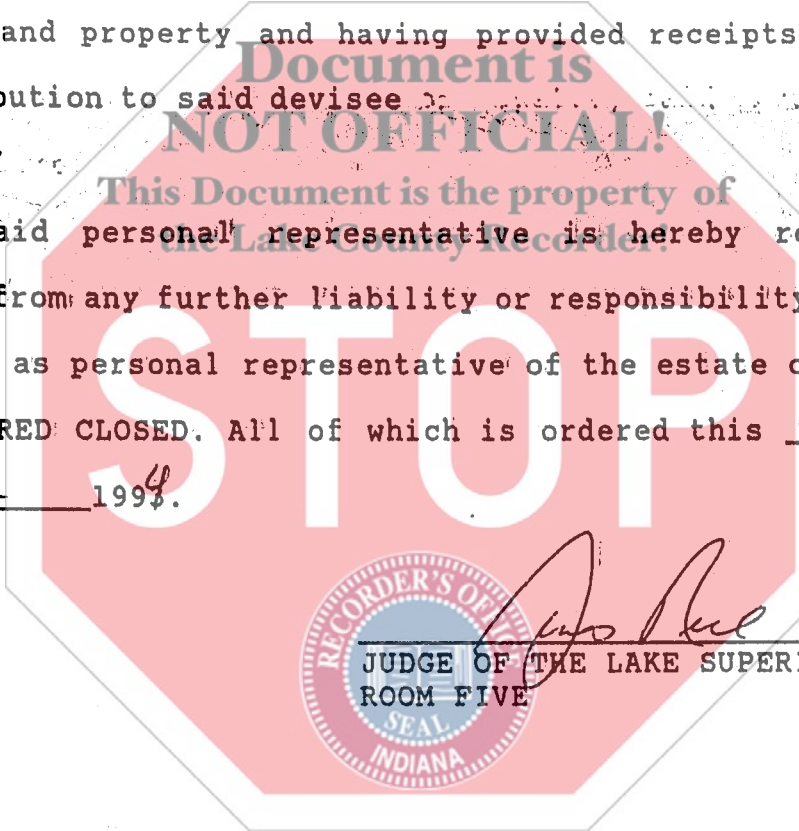
follows:
