Section 321 of the Real Property Law expressly provides who must execute the certificate of discharge in specific case and also provides, among other things, that (1) no certificate shall purport to discharge more than one mortgage, (except that micrograges at least by instruments of consolidation, spreader, modification or correction may be included in one certificate if the instruments are set form in detail in sparate paragraphs).
