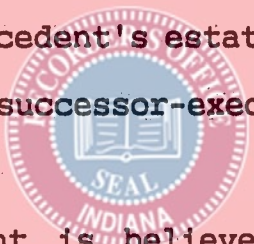
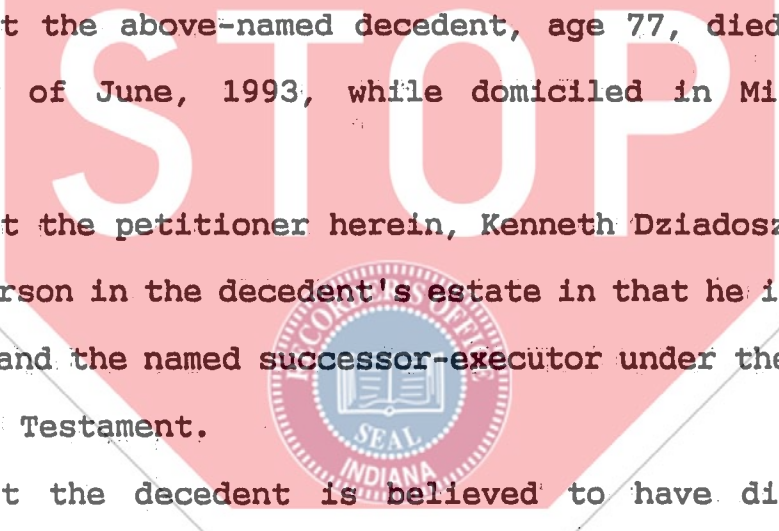

1. That the above-named decedent, age 77, died testate on  
the 24th day of June, 1993, while domiciled in Miami County,

2. That the petitioner herein, Kenneth Dziadosz Sr., is an  
interested person in the decedent's estate in that he is the son of  
the decedent and the named successor-executor under the decedent's

That the name, age, relationship to such decedent, and place of residence of such known legatees and devisees of such decedent's estate are: Kenneth Dziadosz Sr, Age 43, of 456 E. 5th Street, Peru, Indiana, a son, and Kenneth Dziadosz Jr, age 19, of the same address, a grandson. 6. That the decedent's creditors are unknown as of the time of the filing of this petition for the appointment of a personal representative.



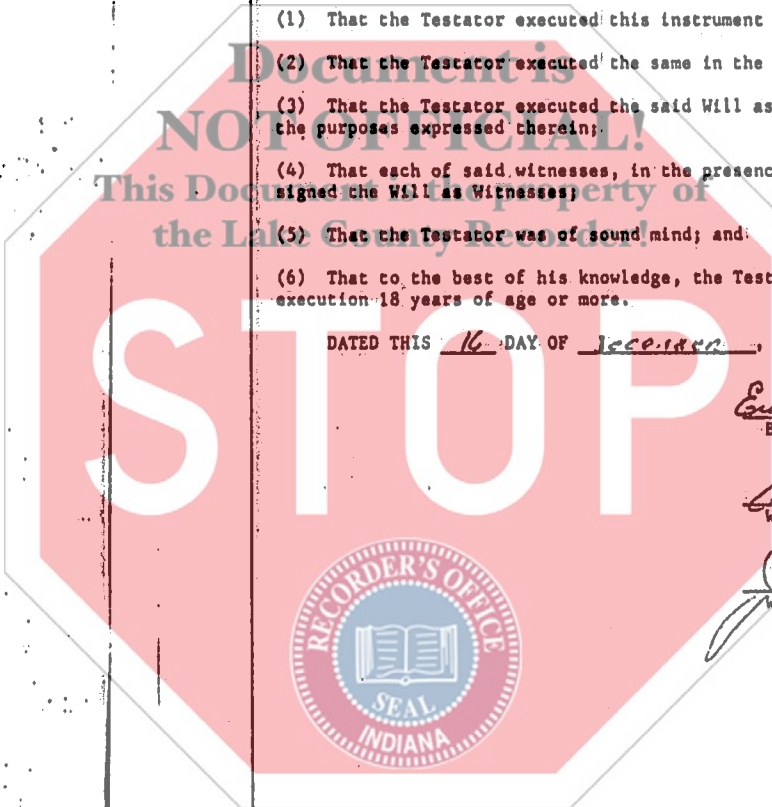
