IT IS THEREFORE ADJUDGED, ORDERED and DECREED as follows:

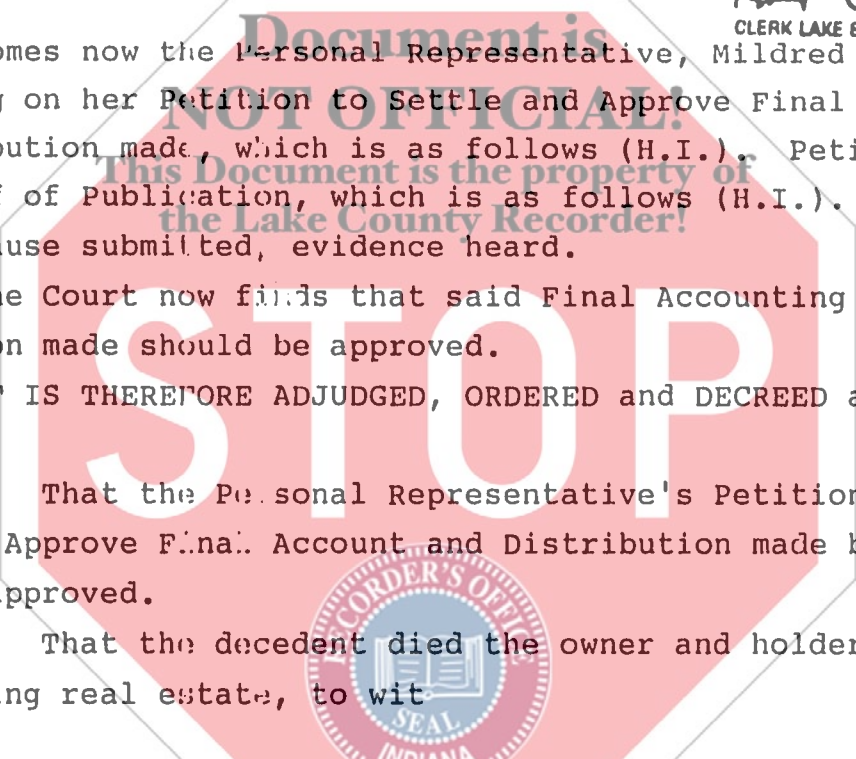
