BUILDER'S LINE OF CREDIT LOAN MODIFICATION AGREEMENT

WHEREAS, the Note and Agreement and Mortgage (Loan Documents) are hereby incorporated herein as part of this Builder's Line of Credit Loan Modification Agreement (Agreement);

WHEREAS, Borrower has requested a modification of the terms of said loan for the purpose of increasing the credit limit from \$200,000.00 to \$255,900:00;

WHEREAS, Lender is willing to increase the credit limit provided that Borrower agrees to pay the costs associated with this Agreement;

- The Credit Limit is increased to \$255,900.00.
- Borrower has paid Lender title expense, recording and appraisal fees, the receipt of which is hereby acknowledged.
- Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or part of the Loan Documents. Except as otherwise specifically provided in this Agreement, the Loan Documents shall remain unchanged and in full effect, and the Borrower and Lender will be bound by, and comply with, all of the terms and provisions thereof, as amended by this Agreement.

LEGAL DESCRIPTION

PARCEL I: Part of the Southwest 1/4 of Section 5 and part of the Northwest 1/4 of Section 8, all in Township 32 North, Range 9 West of the 2nd Principal Meridian, Lake County, Indiana, more particularly described as follows: Commencing at the Southwest corner of Section 5, Township 32 North, Range 9 West of the 2nd Principal Meridian, thence North 89 degrees 49 minutes 08 seconds East, 777.63 feet, along the South line of said Section 5, to the point of beginning; thence North 00 degrees 04 minutes 41 seconds East, 565.24 feet; thence East parallel with the South line of said Section 5, North 89 degrees 49 minutes 08 seconds East, 535.50 feet to the East line of the Southwest 1/4, of the Southwest 1/4 of said Section 5, thence South 00 degrees 04 minutes 41 seconds West, along the East line of the Southwest 1/4 of the Southwest 1/4 of said Section 5, 407.05 feet; thence Southwesterly along a curve concaved to the Northwest having a radius of 2360.61 feet, a central angle of 14 degrees 05 minutes 26 seconds and an arc length of 580.536 feet, to a point of non-tangency lying in the Northwest 1/4 of Section 8, Township 32 North, Range 9 West of the 2nd Principal Meridian, thence North 00 degrees 04 minutes 41 seconds East, 59.76 feet, to the point of beginning, all in Lake County, Indiana.
