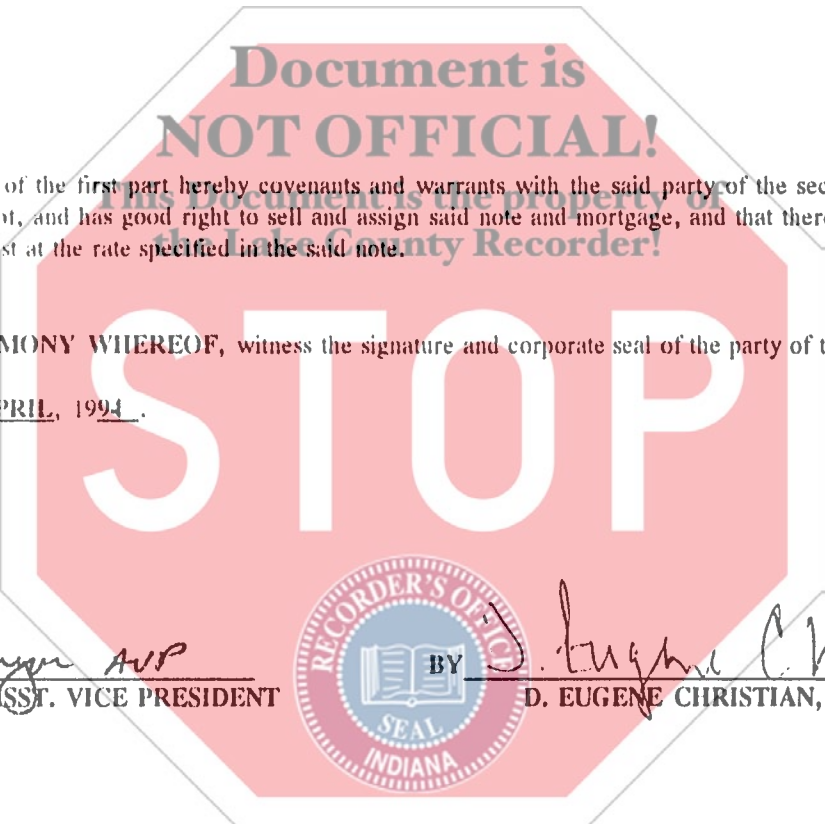
WITNESSETH:
