TOWN OF MERRILLVILLE, INDIANA
AN ORDINANCE VACATING A PORTION OF A DRAINAGE AND UTILITY
EASEMENT IN THE TOWN OF MERRILLVILLE, LAKE COUNTY, INDIANA

WHEREAS, A.H.E.P.A #78, Inc. has a petition to vacate a portion of a drainage and utility easement in the Town of Merrillville, Indiana; and

WHEREAS, a Public Hearing has been held as required by Indiana Code 36-7-3-12; and

WHEREAS, the Town Council of the Town of Merrillville has determined after said Public Hearing that the portion of the drainage and utility easement should be vacated:

NOW THEREFORE, BE IT ORDAINED by the Town of Merrillville, to wit:

1) That the following described portion of a drainage and utility easement be vacated by the Town of Merrillville, to wit:

Lot 5 of the resubdivision of the Lincoln Ridge, in the Town of Merrillville, Lake County, Indiana.

2) The easement Vacation shall take effect immediately upon the recording of this Ordinance with the Recorder of Lake County and shall be delivered to the Auditor of Lake County for posting to the Auditor's records.
