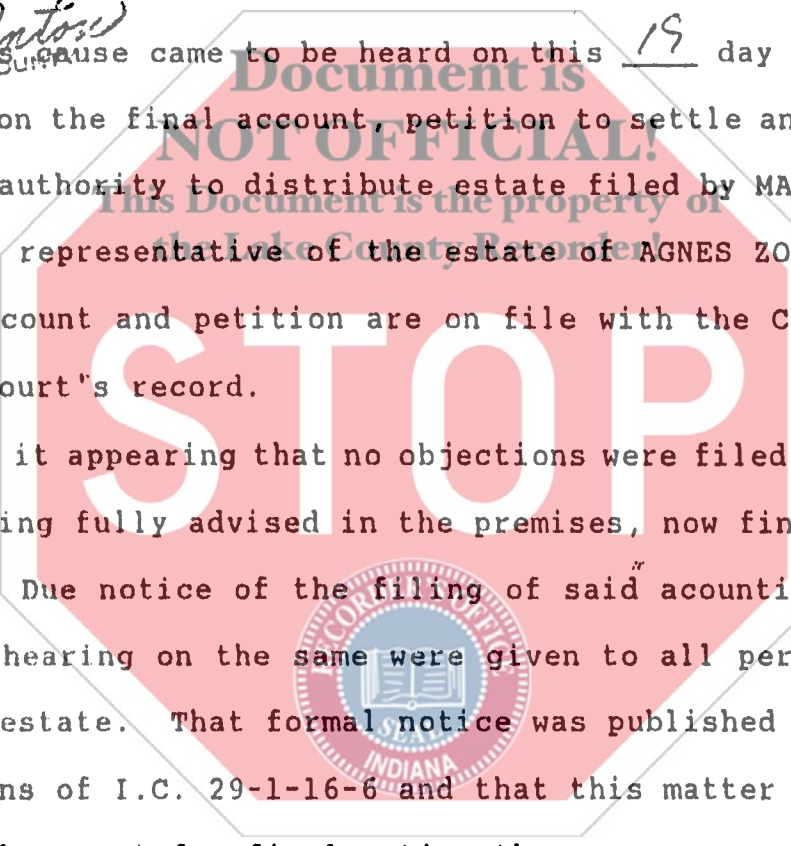
This cause came to be heard on this 19 day of April,

2. That AGNES ZORICK died intestate a resident of Lake

said personal representative was issued Letters of Administration
on the 28th day of October, 1992, to her and since that date she
has continued to serve in such capacity.

as tenants in common, and a copy of this decree showing the vesting of said real estate should be recorded in the office of the County Recorder in which said real estate is located.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Accounting of said personal representative is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said personal representative's hands for distribution has been made pursuant to the distribution set forth in the final accounting to the decedent's heirs at law and is hereby in all things approved.

3. That pursuant to the laws of intestacy, the following described real estate, to-wit:

Lot Sixteen (16), Seventeen (17) and Eighteen (18), in Block 3, in Mack Company's First Addition to Gary, Lake County, Indiana, as per Plat Book 7, Page 19, recorded in the Recorder's Office of Lake County, Indiana.

is hereby vested in Michael Zorick, John Zorick, Sr., Frank Zorick, Lucy Chase and Margaret Woods as tenants in common.


And that said personal representative is hereby directed to procure and record in the office of the Recorder of Lake County, being the county in which said real estate is located, a certified copy of this Final Decree.
