The defendant, Transamerica Commercial Finance Corporation, having moved this Court for summary judgment and the matter having come on before this Court and the Court finding that there does not exist any genuine issue of material fact and that these parties are entitled to summary judgment as a matter of law;

IT IS HEREBY ORDERED AND ADJUDGED as follows:

1. That there are sufficient minimum contacts between the intervening defendant, James R. Bates, with the State of Kentucky to satisfy the due process requirements for personal jurisdiction over defendant Bates and therefore the defendant Bates is subject to the jurisdiction of this Court.

2. That the defendant, Transamerica Commercial Finance Corporation, is granted judgment against James R. Bates as guarantor of the indebtedness of J. B. Holding, Inc. in the amount of \$157,455.26 together with interest thereon from and after June 30, 1992 at the daily interest rate of \$59.83 until paid, plus its court costs and reasonable attorney fees incurred herein.
