And whereas, the party of the first part, at the request of the party of the second part, has agreed to cancel said assignment of Leases and Rents.

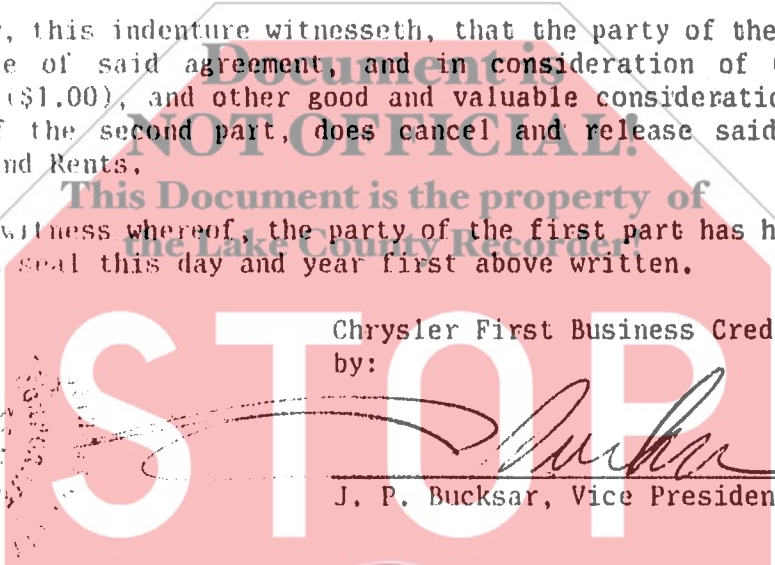
