said Obligee and this bond shall be deemed cancelled at the expiration of said thirty (30) days; but said Surety, so filing said
notice shall not be discharged from any liability already incurred under this bond or which shall accrue hereunder before the
expiration of said thirty (30) day period.

This bond may be continued from year to year by means of a continuation certificate.

**Power of Attorney

KNOW ALL MEN BY THESE PRESENTS: That STATE FARM FIRE AND CASUALTY COMPANY, an Illinois corporation, with its principal office in Bloomington, Illinois, does hereby constitute and appoint: **JIMMELLS** of CHESTERON, IN, its true and lawful Attorney-in-Fact, to make, execute, seal and deliver for, and on its behalf as surety, any and all bonds, undertakings, on other writings, obligatory in the nature of a bond as follows:

\$1,500 - License Permit and Indemnity Bonds which guarantee payment.	\$50,000 - Administrator, Executor, Trustee of a decedent's estate
\$10,000 - License & Permit which do not guarantee payment - (Code Compliance only)	\$25,000 - Guardian, Conservator, Committee
\$10,000 - Public Official	\$10,000 - Trustee in Bankruptcy or Receiver, Court Bond
	\$2,000 - Real Estate Court Bond

THIS POWER OF ATTORNEY IS NOT VALID FOR THE EXECUTION OF ANY CONTRACT (CONSTRUCTION OR SUPPLY) BOND - BID, PERFORMANCE OR PAYMENT

This appointment is made under and by the authority of a resolution which was passed by the Executive Committee of the Board of Directors of State Farm Fire and Casualty Company on the 24th day of July, 1974, as is duly authorized by the Board of Directors in Article III, Section 6(b), the By-Laws of the Company, which resolution is:

Resolved, that the Executive Vice-President or a Vice-President of the Company is hereby authorized to appoint and empower any representative of the Company or other person or persons as Attorney-in-Fact to execute on behalf of the Company any bonds, undertakings, policies, contracts of indemnity or other writings, obligatory in the nature of a bond, which the Company might execute through its duly elected officers, and affix the seal of the Company thereon. Any said execution of such documents by an Attorney-in-Fact shall be as binding upon the Company, as if they had been duly executed and acknowledged by the regularly elected officers of the Company. Any Attorney-in-Fact, so appointed, may be removed for good cause and the authority so granted may be revoked as specified in the Power of Attorney.

Resolved, that the signature of the Executive Vice-President or any Vice-President and the seal of the Company may be affixed by facsimile on any power of attorney granted; and the signature of the Secretary, Vice-President or Assistant Secretary and the seal of the Company may be affixed by facsimile to any certificate of any such power and any such power or certificate bearing such facsimile signature and seal shall be valid and binding on the Company. Any such power so executed and sealed and certificate so executed and sealed shall with respect to any bond or undertaking to which it is attached, continue to be valid and binding on the Company.

IN WITNESS THEREOF, STATE FARM FIRE AND CASUALTY COMPANY has caused this instrument to be signed by its Vice-President and its Corporate Seal to be affixed this 1st day of March 1991.

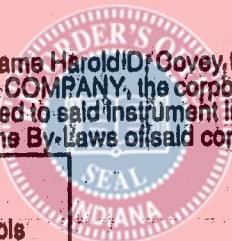
