- 1t Payment of Principal and Interest. Borrower shall a promptly pay when a due the principal and interest indebtedness evidenced by the Note and late charges as provided in the Note, all without relief from valuation and appraisement laws. - 17. Assignment of Rents; Appointment of Receiver.
