Schulte and Martha Schulte, husband & wife dated February 15, 1937, recorded February 18, 1937, in Book 287, Page 246, in the Recorder's Office of Lake County, Indiana, in consideration of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged does hereby REMISE, RELEASE AND FOREVER QUIT CLAIM to August A. and Martha Schulte and to their successors and assigns, all the right, title and interest acquired under the aforesaid easement for electrical lines, in, upon, along and over the premises situated in Lake County, Indiana, described as follows:

A strip of land containing .027 acres, more or less in the NE 1/4 of Section 19, Township 36 North, Range 9 West of the 2nd Principal Meridian being 10 feet wide lying 5 feet each side of a center line and said center line produced, said center line being described as follows:

Beginning at a point 191 feet east of the West line of the E 1/2 NE 1/4 of Section 19 and 1153.2 feet North of the South line of the NE 1/4 of Section 19; thence North and parallel to the West line of the E 1/2 NE 1/4 of Section 19, a distance of 117.5 feet.

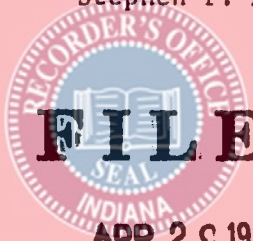

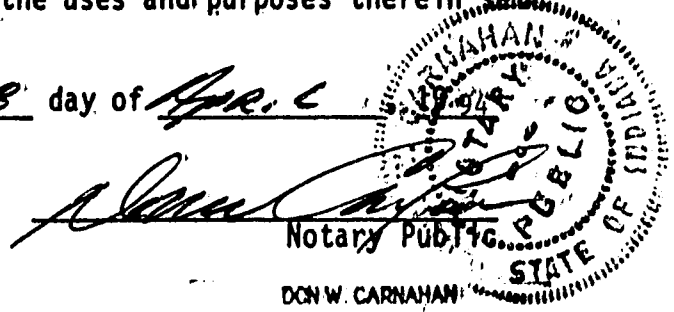
